## FOOD SERVICE CHARGES AT THE MILITARY ACADEMIES FISCAL YEAR 1999

The provisions of Chapter 20, "Military Academy Dining Hall Operations," of Volume 12, "Special Accounts, Funds and Programs," of DoD 7000.14-R, <u>DoD Financial Management Regulation</u>, provide that the daily amount of subsistence will be prescribed by the Secretary of Defense for each Military Department that operates a Service Academy dining hall in support of cadets or midshipmen. The daily academy dining hall rates for FY 1999, effective October 1, 1998, are shown below:
