FEE EXEMPTIONS:

Additionally, there is no fee required for applications filed with purposes of Amendment to a Pending Application, Request for Cancellation of License, Request for Withdrawal of Application, Administrative Update, or Minor Modifications, Request to Consolidate Call Signs, Notification of Construction/Coverage Requirements, or Notification of Consummation and Request for Extension of Time for Consummation.

METHOD OF PAYMENT
