ADVICE REFERENCE GUIDE HOW TO USE FCC FORM 162-(CORES) CERTIFICATION FORM

The FCC Form 162, ("CORES Certification Form") is a form that must accompany any non-feeable application submitted to FCC. The information on this form is collected, to service public inquiries, and to comply with the Debt Collection Improvement Act of 1996.

Instructions for Completing FCC Form 162

- (1) **FCC Registration Number (FRN)** Enter the entity's ten-digit FCC Registration Number (FRN) assigned by the Commission Registration System (CORES). The FRN is a unique entity identifier for everyone doing business with the Commission. The FRN can be obtained electronically through the FCC webpage (www.fcc.gov) or by requesting FCC Form 160 through the FCC forms webpage (www.fcc.gov/formpage.html).
- (2) **Entity Name** Enter the entity name of the person or company as registered with the FCC. If using an individual name, enter the last name, first name, and middle initial. If a company, enter the name used commercially.
