Introduction

This FCC Form is to be used to certify that construction of an Instructional Television Fixed Service (ITFS) Station or ITFS signal booster station has been completed and that the station is now operational and in accordance with an authorized construction permit.

Applicable Rules and Regulations

Before this form is prepared, the licensee should review the relevant portions of Parts 0, 1, 17 and 74 of the FCC rules in Title 47 of the Code of Federal Regulations (C.F.R.). Copies of Title 47 may be purchased from the Superintendent of Documents, Government Printing Office, Washington, DC 20402. You may telephone the GPO order desk at (202) 512-1800 for current prices. Licensees should make every effort to file complete and accurate forms in compliance with the rules. Replies to questions on this form and the licensee's statements constitute representations on which the FCC will rely in considering the certification of completion of construction. Paper Copies

All entries on this form shall be typed or legibly printed in ink. A separate FCC Form 330A must be submitted for each ITFS station and for each permit being covered. ITFS stations must be constructed as authorized. An FCC Form 330 must be filed for proposed modifications. Submit an original and one copy of the completed FCC Form 330A.

Incorporation by Reference

You may not incorporate by reference data, documents, exhibits, or other showings already on file with the FCC. All applicable items on this form must be answered without reference to a previous filing.

Current Information

Information filed with the FCC must be kept current. The licensee shall notify the FCC regarding any material change in the facts as they appear on the FCC Form 330A. See 47 C.F.R. Section 1.65.

INSTRUCTIONS FOR SPECIFIC ITEMS ON FORM

Questions 1-11. The legal name of the licensee should be the same as reported on the FCC Form 330 permit for which this form is intended to cover. Licensees must provide a current and valid mailing address, and this address must not be the address of an equipment supplier, attorney, consultant or other third party. See 47 C.F.R. Section 1.5.

Enter the applicant's ten-digit FCC Registration Number (FRN) assigned by the Commission Registration System (CORES). The FRN is a unique entity identifier for everyone doing business with the Commission. The FRN can be obtained electronically through the FCC webpage at <http://www.fcc.gov> or by manually submitting FCC 160. LICENSE AND STATION LOCATION INFORMATION

Question 12. A separate FCC 330A must be submitted for each ITFS permit being covered. For this question, provide the channel(s) or channel group which the FCC 330A is intended to cover.

Question 13. Provide (a) the file number of the permit application this FCC 330A is intended to cover, and (b) the date the permit was granted by the Commission.

Question 14. Indicate (a) the date construction was completed, and (b) the date service to the public is to commence.

Questions 15-17. List the city, state and county/borough/parish of the location of the transmitter site as found in the FCC 330 of the permit being covered.

Question 18. Specify the geographic coordinates of the location of the transmitting antenna site (NAD27 datum) as authorized in the permit being covered.

Question 19. Applicants may not operate with facilities at variance with those authorized in their construction permit. Any changes requiring an FCC 330 to modify the facility must be filed immediately.

Question 20. This item identifies the contact representative (usually the headquarters office of a large licensee, the law firm or other representative of the licensee, or the person or company that prepared or submitted the filing on behalf of the licensee). In the event there is a question concerning the filing, the FCC will attempt to communicate with the contact representative first.

CERTIFICATIONS

Question 21. The engineering certification must be signed by the person responsible for preparation of the engineering information.

Question 22. Certification on behalf of the licensee must be made personally by the individual licensee, a partner (if the licensee is a partnership), a corporate officer or duly authorized employee (if the licensee is a corporation and that employee has been specifically authorized to act for and on behalf of the licensee), or officer/member (if the licensee is an unincorporated association). Paper originals of applications must bear an original signature. Neither rubber-stamped nor photocopied signatures are acceptable.
