SUBJECT: Quarterly Update to Correct Coding Initiative (CCI) edits, Version 10.3, Effective October 1, 2004.

I. GENERAL INFORMATION

The latest package of Correct Coding Initiative (CCI) edits, Version 10.3, effective October 1, 2004, will be available via the CMS Data Center (CDC). A test file will be available on or about July 30, 2004, and the final file will be available on or about August 16, 2004. Version 10.3 will include all previous versions and updates from January 1, 1996, to the present and will be organized in two tables: Column 1/ Column 2 Correct Coding Edits and Mutually Exclusive Code (MEC) Edits.

- **A. Background:** The Centers for Medicare and Medicaid Services developed the National Correct Coding Initiative to promote national correct coding methodologies and to control improper coding that leads to inappropriate payment in Part B claims.
- **B.** Policy: The coding policies developed are based on coding conventions defined in the American Medical Association's Current Procedural Terminology manual, national and local policies and edits, coding guidelines developed by national societies, analysis of standard medical and surgical practice and review of current coding practice.
- **C. Provider Education:** "A provider education article related to this instruction will be available at www.cms.hhs.gov/medlearn/matters shortly after the CR is released. You will receive notification of the article release via the established "medlearn matters" listserv. Contractors shall post this article, or a direct link to this article, on their Web site and include information about it in a listserv message within one week of the availability of the provider education article. In addition, the provider education article must be included in your next regularly scheduled bulletin."
