## Foreign Buyers List.

This database contains information on more than 25,000 foreign buyers of food, farm, fish and forest products in 80 countries. Each Foreign Buyers List provides important information on the foreign firm such as contact person, address, telephone, fax and type of product(s) imported.

You may order Foreign Buyer Lists in different formats:

1. hard copy
2. labels – only name and address available

Lists are available by product for a specific country – all known buyers of a specific product identified in a specific country. Lists are available by country groups where possible. Group lists are outlined on the order form. Please note that the availability of country lists and groupings is subject to change. Please contact the AgExport Connections Office for the latest information.

Please Note: There is a \$15 service fee for each Foreign Buyer List requested. Payment may be made by check, money order, bank draft, or credit card and **must be included with the order form**. Orders may be submitted by fax only if payment is made by credit card. No COD or invoice orders will be accepted. All checks, money orders etc. should be made payable to **FAS-USDA**. Do not submit cash. Orders are mailed First Class unless another method is specified.

Orders are processed within three days of receipt and the printed Foreign Buyers List are sent by First Class mail. Lists can also be shipped by Federal Express and charged to your FEDEX account or credit card. Please note that we **DO NOT FAX** any Foreign Buyer Lists.

To order select the type of list(s) you want from the attached index. Then legibly print or type the code and description for each product, country or combination list in the space provided on the back of this form. (You may copy this order form if needed.)
