- ▶ **REFUNDS ARRIVE FASTER**— Your clients receive their refunds in half the time as paper filers—choosing Direct deposit they will have it in as few as 10 days.
- ▶ **RETURNS ARE ACCURATE**— IRS automatically checks for missing information or errors and electronically acknowledges receipt of individual income tax returns within 48 hours.
