Note: This table represents the most current data available from the General Services Administration. Data does not include inland water. The BLM is not able to verify the complete accuracy of the data and footnotes provided in this table. For data related to lands that fall under the exclusive jurisdiction of the BLM, see Table 1-4.

/a/ “Public domain” is defined to cover original public domain lands and those withdrawn from the original public domain for specific uses (i.e., national parks, national forests, military installations) of various Federal agencies. The term “original public domain land” embraces all the area to which title was vested in the U.S. Government by virtue of its sovereignty. Public domain lands also include lands within Federal ownership that were obtained by the Government in exchange for public domain lands that have reverted to Federal ownership through the operation of public land laws.

/b/ “Other” is defined to cover land acquired by purchase, condemnation, donation, exchange, and other methods of acquisition (other than public domain).
