FOOTNOTES

- /a/ Authorized leases, licenses, and permits are shown, along with those logical mining units that are approved. Totals include new actions during the fiscal year as shown in the three right-hand columns. New actions show the number of leases, licenses, and permits authorized and logical mining units approved with effective dates during the fiscal year. Pending preference right lease applications are shown. These include preference right lease applications that may have been rejected by the Bureau of Land Management but that are, or were, under appeal to the Interior Board of Land Appeals as of September 30, 1999.
- /b/ Acreage numbers may have changed slightly from previous years due to rounding changes associated with new automated tools used to extract and compile the data.
- /c/ A single coal sale resulted in the issuance of one new lease and the creation by assignment of second lease from that newly issued lease. Both leases share the same fiscal year 1999 effective date.
- /d/ FCLAA is the Federal Coal Leasing Amendments Act. The Pre-FCLAA Lease case type includes both competitive and noncompetitive coal leases issued prior to August 4, 1976.
- /e/ These five leases were transferred from the State of Utah on January 8, 1999. These leases retain their original effective dates, so they are not shown as newly issued leases.
