**SUBJECT:** Resident Assessment Instrument (RAI) Training Program

# **Letter Summary**

- A new RAI Training Program will assist State Survey Agencies (SAs), particularly RAI coordinators, with training providers.
- These materials are designed for use in conducting in-service training for nursing home staff in various sections of the RAI.
- Each training tool is based on national CMS policy to encourage consistent and accurate administration of the RAI nationally.
- Use of these materials is required for RAI Coordinators for training sessions this year.
- This letter includes a schedule of training products and release dates.

The Centers for Medicare & Medicaid Services (CMS) recognizes a need for training materials based on national policy and produced at a national level to assist with the administration of the RAI. The RAI collectively includes the Minimum Data Set (MDS), the Resident Assessment Protocols (RAPs), and the Utilization Guidelines also known as the RAI manual. CMS uses a train-the-trainer model. State RAI Coordinators, with guidance from CMS regional offices (ROs) and Central Office (CO), are tasked with training providers in their respective States. The State RAI Coordinators are federally funded positions within the State SAs.

The MDS is a comprehensive instrument that serves many masters, including: survey, quality, and payment. To that end, CMS is making a concerted effort to provide a suite of training tools designed to achieve consistent and accurate coding nationally. Since different people learn in different ways, these tools include a variety of media such as written and visual presentations, training videos, a prototypical medical record, internet-based training tools, a library of CMS approved training presentations on multiple topics, answers to questions, and RAI manual updates.

These training tools were largely developed based on pilot test results from the Data Verification and Accuracy (DAVE) reviews of real MDS forms in nursing homes. Analysis of the results of this process identified problematic coding areas of the MDS including Sections G, P, O, I, and J. CMS used these results as well as national policy to describe the correct coding of the MDS.

CMS believes that this core set of materials will be useful to the ROs and the RAI Coordinators in reducing the need to constantly develop new training materials, although additional materials may be necessary for some training efforts. Furthermore, the web-based lessons will be available on the Internet for any provider staff to access at any time. We will be announcing the web address through various means including our own web-site as the implementation date approaches. According to the FY 2005 Budget Call letter, each RAI Coordinator is required to conduct at least two training sessions for providers in their State using these materials in FY 2005.
