

# Region 3 Candidate Species List

## U.S. Fish and Wildlife Service

Region 3 (Ill., Ind., Iowa, Mich., Mo., Minn., Ohio, Wis.)

**Candidate species** are plants and animals have been studied, and U.S. Fish and Wildlife Service (Service) has decided that they should be proposed for threatened or endangered status. The listing priority number indicates the general order in which they will be proposed. The pace at which new listing proposals are completed depends upon the funding appropriated by Congress to the listing and classification portions of the Service budget. While candidate species are not protected by the Act, some Federal candidate species **are** protected by State laws. (Bold type indicates states that are within Region 3.)
