Dear Congressman Waxman:

This letter is in final response to the letter that you and certain other members of the Committee on Government Reform sent to Secretary Abraham on January 15, 2004. The Department of Energy (DOE) sent an earlier partial response to your letter on January 15, 2004.

You requested "copies of all communications relating to H.R. 6 since November 21, 2003, between (1) DOE or other Executive Branch officials and (2) industry lobbyists, representatives of trade associations or interest groups, or other persons outside of the Executive Branch." We do not understand your request to call for communications between DOE and Members of Congress or their staff. DOE searched for responsive documents in the Offices of the Secretary, Deputy Secretary, Under Secretary for Energy, Science and Environment, Assistant Secretary for Congressional and Intergovernmental Affairs, Scheduling and Advance, and Executive Secretariat. DOE determined that these offices were the ones most likely to have documents that were responsive to your request. Enclosed are copies of documents that DOE has located that are responsive to your January 15 request.

- **Schwarzenegger picks Dan Skopec as an energy adviser**

The exact title is deputy cabinet secretary for energy, resources and environmental issues. In recent years he's been staff director of the Government Operations Subcommittee on Energy Policy, Natural Resources & Regulatory Affairs in Washington.

- **What's a good name for a creative energy ad company?**

When Creativenergy founders Eric Tulin, a veteran adman, and John Kearney, a former Connecticut Natural Gas sales executive, were looking for an interesting niche for their new marketing communications firm, they came up with clean energy. They like the challenge, Tulin told RT yesterday from his office in Bristol, Conn (www.creativenergy.biz), and figure renewable and alternative energy have a lot of growth potential in deregulated markets worldwide.

- **Stakeholders would block New England RTO**

NEPOOL these days is not the grid owners' country club of yore. It's a voluntary collection of generators, grid owners, energy suppliers, marketers, municipals and power users. They're very upset at a bid by ISO New England and seven transmission owners to set up an RTO in the region without the approval of the overwhelming majority (80%) of NEPOOL stakeholders.

- **What does Abraham really want?**

FERC Chairman Pat Wood upset DOE Secretary Spencer Abraham with his talk of mandatory reliability standards by summer. Without an energy bill, it isn't certain whether mandatory electricity reliability standards could be enforced by FERC, Abraham told the press.

- **Ohio advocate sees need for seamless PJM-MISO market**

The Aug 14 blackout points out the urgent need for a seamless Midwest ISO-PJM market, Eric Stephens, deputy consumers' counsel in Ohio (OCC), told the US-Canada outage task force in their Cleveland meeting yesterday. Case in point: MISO was late in diagnosing the impending crisis because an operator, frustrated that he was unable to monitor a line's status of PJM-member Dayton Power & Light, had turned off a monitoring system, the OCC told a hearing.

- **Half would pay more to fix grid's ills**

If consumer attitudes are any indication, it's going to be tough to sell higher power prices for reliability improvements, a new survey found. AUS Consultants interviewed 1,024 consumers nationwide -- half of them victims this year of outages lasting 30 minutes or more -- and found 40% were unwilling to pay higher rates to

improve the nation's grid.

• **UK suppliers fined for failure to switch customers**

Ofgem, the UK gas and electric markets regulator has penalized Scottish Power and npower for refusing to switch some 9,000 direct-debit customers on equal payment plans. They had paid on time but owed money because payments hadn't caught up with use, Ofgem said.

• **How to sell solar power in sunny Arizona**

Arizona Public Service (APS) is doubling its solar credit to kickstart a program that offers up to \$1 million in solar system rebates but has had few grid-connected takers. Nearly 200 customers signed up in remote locations over the past two years for a \$2/watt credit but fewer than 20 who aren't off the grid took the deal.

• **Group favors bold program to jumpstart solar market**

Though better technology and friendlier government policies might keep solar energy growth slow and steady, spectacular growth needs "audacious measures," says research and strategy firm Clean Edge in a report for the Solar Catalyst Group (SCG). Solar energy growth is slow because systems are being produced on a small scale -- keeping quantities low and prices high -- and are not standardized so they're expensive and complex to install.

Alliance Urges Passage of Energy-Efficiency Provisions As Energy Bill Sits in Limbo



With the energy bill on hold, the Alliance to Save Energy urged U.S. lawmakers to enact the bill's non-controversial energy-efficiency provisions -- agreed to months ago on a bipartisan basis -- when they return in January. Then, the Alliance said, Congress must craft a broader energy policy that uses efficiency to tackle persistent problems such as U.S. oil dependence and electricity reliability. The Alliance also called on lawmakers to extend authority for the federal government to enter into Energy Saving Performance Contracts, which allow the government to pay for energy improvements with the resultant energy savings. The Senate recently abandoned attempts to pass comprehensive energy legislation this year but may return to the energy bill after Congress reconvenes in January. [Alliance News Release](#)

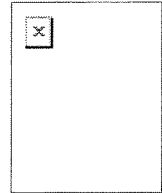

Metromedia locks horns with WGL over credit policy

Virginia regulators heard last week from Washington Gas Light (WGL), one of the protagonists in a quarrel over how much security gas marketer Metromedia Energy has to post for next year. It's not the first spat between a competitive supplier and LDC over credit requirements and won't be the last.

FERC plans action to end system vulnerability

Energy bill or not, FERC will continue the transition of the electric power industry, Commissioner Nora Brownell promised. "We're incredibly vulnerable in this transition," Brownell told the Energy Bar Assn, citing a litany of problems that include an inability to attract capital at reasonable rates, a lack of innovation in new technologies and a lack of regional planning.

FERC needs congressional assist to act

Another speaker at the bar association session, former FERC general counsel William Scherman of Skadden Arps, doesn't think FERC efforts will alone be enough without Congress' help. He cited the value of the Energy Policy Act of 1992 to progress in areas such as wholesale competition and open access in transmission, terming EPAct "successful in setting the direction and confirming the direction of the commission "beyond my wildest dreams."

Tauzin uses Henry Hub spike to promote energy bill

When House Energy & Commerce Committee Chairman Billy Tauzin, R-La, saw the Energy Information Administration (EIA) report that natural gas prices have jumped to over \$6 he issued an explanation. Tauzin who represents gas country cited the larger than expected dip in gas inventories that pushed markets 54% above the \$4.13 of last December -- and winter hasn't officially started yet.

CLARIFICATION: David Hawk, energy buyer for JR Simplot, the \$3 billion/year food conglomerate, thinks we went a bit hard on the Idaho PUC for getting the troops stirred up about gas prices. He called about (RT, 11/25) our version of "Idaho PUC predicts high gas prices."

ISO New England plugs tough grid rules, penalties

Grodon van Welie runs ISO New England and believes strongly, independent RTOs are critical for reliability, he told the US-Canada blackout task force. Certainly the Midwest ISO's "Swiss cheese" approach to power system dispatch and management needs to be eliminated.

NW to weigh BPA role in markets, pricing

The Northwest Power Conservation Council (formerly Power Planning Council, NWPPC) meeting this week in Portland, Ore, is focusing on BPA's future role with some urgency "before another crisis develops." The region's governors recognize "that perpetuating uncertainty" puts the region's power supply adequacy and economy at risk.

New York kind of boosts onsite power

Onsite power got a big boost in New York this week with PSC action on statewide natural gas tariffs that will save most DG owners fuel dollars and a final decision on standby rates for Central Hudson Gas & Electric. Those are two of the crucial elements driving DG development in New York -- the new hot market for onsite power.

Superconductor's Howe would use market prices as tool

FERC rules on ancillary services pricing are skewed toward "more costly and less effective" generation-based approaches, American Superconductor (ASC) told commissioners and that creates barriers to new technology solutions. The reason: utilities have viewed reactive power (VAR) -- one of the needs identified by investigators of the Aug 14 blackout -- as a generator function, wrote John Howe.

Walter Higgins tells lawyers about bad policy

Walter Higgins is still sore about shareholders at Sierra Pacific Resources getting stuck with a big piece of the spiking prices when the PUC wouldn't pass the higher costs along to the customers. The US not only lacks a competitive short-term market in electricity -- except in a few narrow areas -- but he doesn't see the possibility of getting one.

Buying IP would help sort out MISO identity

Ameren is chatting with Dynegy about buying Illinois Power now that Exelon is out of the picture. Ameren had adamantly opposed the legislative concessions Exelon proposed but failed to get.
