UPDATES TO STATISTICAL AREAS December 2003

This attachment highlights updates to the statistical areas based on the application of the 2000 Standards for Defining Metropolitan and Micropolitan Statistical Areas to Census Bureau population estimates for 2001 and 2002. Thomasville, NC replaces Lexington, NC as the largest principal city within the Lexington-Thomasville, NC Micropolitan Statistical Area. New title: Thomasville-Lexington, NC Micropolitan Statistical Area. As a result of this change, the code for the area is now 45640.

Other Title Changes

The title of the Buffalo-Cheektowaga-Tonawanda, NY Metropolitan Statistical Area has changed. The new title is Buffalo-Niagara Falls, NY Metropolitan Statistical Area.
