

Hall of Fame Nomination Guidelines

Background and Purpose

The Cooperative State Research, Education, and Extension Service of the Department of Agriculture (CSREES, USDA) is establishing a **CSREES Hall of Fame.** Inductees into the **CSREES Hall of Fame** must have worked, coordinated, or supported activities exemplifying CSREES' synergy of excellence in any combination of research, education and extension approaches on local, regional, national, or international levels, and will have demonstrated a measurable and positive impact on the lives of citizens. Up to ten members of the **CSREES Hall of Fame** will be inducted during the Agency's tenth year anniversary celebration in October 2004. Subsequent recipients will be inducted into the **CSREES Hall of Fame** during an annual awards ceremony, pending identification of at least one qualified nominee. The call for the **CSREES Hall of Fame** nominations will be issued via various electronic distribution lists and the CSREES web site. A Committee will review the nominations and recommend deserving nominees for final selection to the CSREES Administrator.

Nomination

- 1) Nominees may be living or deceased.
- 2) Nominations will be accepted from:
 - a) CSREES or CSREES Partner Organizations (Land-grant and partner institutions). Each partner organization will conduct its own internal review and screening process prior to submitting one nomination to CSREES.
 - b) Individuals.
- 2) A complete nomination package includes:
 - a) A completed Information Cover Page.
 - b) A completed Hall of Fame Nomination Form describing how the nominee implemented, coordinated or supported any combination of research, education, or extension approaches to impact citizens' lives locally, regionally, nationally, or internationally. Nominees may demonstrate this ideal individually through local programs or activities; or on a larger scale (regional, national, international) by demonstrating a high level of support or encouragement, or direct coordination of others in research, education, and extension efforts toward a unified objective or impact, with demonstrated, measurable impact.
 - c) A completed Nominator's certification form.
 - d) Up to three (3) letters of endorsement.

Evaluation Criteria

40 POINTS: Synergy of Research, Education, Extension, and nominee's role.

40 POINTS: Measurable Impact on citizens.

20 POINTS: Endorsement/letters of support.

Annual Program Schedule

Request for Nomination May 1

Submission of Nominations July 1, in our Washington DC office by COB 5:00 pm EDT

Selection of Nominations August 1
*Notification August 15

Awards Ceremony October (third week)

*CSREES Hall of Fame nominators will be notified by August 15, 2004.

Unsuccessful nominations will receive notification after the National Induction Ceremony.

Submission of Nomination

Clearly describe how the nominee's support was critical to enable the implementers/coordinators to achieve the measurable impact described.

Letters should clearly express how the nominee affected change as a result of their role in programs or activities as implementer, coordinator, supporter, or other for positive, measurable impact on citizens locally, regionally, nationally, or internationally.
