Subject: Coordination of Permitting Activities with the Mine Safety and Health Administration

1. Purpose. This directive outlines policy and procedures regarding coordination between the Mine Safety and Health Administration (MSHA) and the Office of Surface Mining Reclamation and Enforcement (OSMRE) as required by the Federal regulations at 30 CFR Part 773.13(a)(3)(ii) and sections 503(a)(6) and 504(h) of the Surface Mining Control and Reclamation Act of 1977. This document also provides guidance to OSMRE personnel involved in oversight evaluation of State programs concerning permit approval coordination with MSHA.

2. Definitions. None.

3. Policy/Procedures.

a. Background and General Policy. Under permanent program requirements, individual coal mine operators are required to submit a permit application to the Federal or State regulatory authority in order to obtain approval to operate a surface coal mining and reclamation or coal exploration operation. Included in permit applications and permanent program performance standards are certain proposed operation and reclamation plans that require the expert review and approval of MSHA in conjunction with OSMRE or State regulatory authorities concerned with the safety of mine workers and the protection of underground mines.

OSMRE, State regulatory authorities or permit applicants are required to obtain MSHA approval during the permit application review process as required by the Federal regulations listed in Attachment A and by State counterparts to the Federal regulations. This directive establishes procedures for the coordination of MSHA approvals for permit applications under a Federal regulatory program and OSMRE oversight evaluation of State program coordination with MSHA in the State program permitting process.

b. Procedures.

(1) Federal Program.

(a) Field Offices responsible for Federal program states should develop a working agreement with the local MSHA office District Manager to provide for the required MSHA review and approval of proposed operation and reclamation plans listed in Attachment A.
