In order to accommodate changes in oversight inspection reporting procedures and to enhance the Minesite Evaluation Inspection Report computerized database system the following additions and changes are made to section 4.c. Procedures in Directive INE-23.

**Item 12: Inspection Type.**

**TDF:** This code is unnecessary and deleted. Inspections related to this former code would fall under code OF.

**COI:** This code is unnecessary and deleted. Complete inspections should all fall under codes C, FC, or SC.

**CCR:** This code has been added and will be used when referring a citizen complaint to a State regulatory authority through a ten-day notice where no inspection is conducted.

**SOx:** This code is replaced by new codes **SC** and **SP**. These codes refer to in-depth complete or partial inspections conducted for the purpose of reviewing a particular aspect of a State program (also known as special study, stratified, selective, or special focus inspections). On the inspection report Code Sheet, Codes SC/SP 1 and 2 are pre-established and shall be used by all Field Offices when the kinds of review they denote are conducted. The "x" denotes where Field Offices shall assign either a one digit number or single capitalized letter in order to identify the subject of the in-depth review for which the inspection applies.

**OFx:** Clarified to read: This code is used to identify follow-up inspections not covered under follow-up inspection codes FF and CCF. The same method of coding described above with respect to the two pre-established codes and the "x" entries also apply here.

**CHANGE NOTICE**

**Item 14: Permit Status.** Three subsets of Abandoned Sites (code AB) have been added: AB1 Bond Forfeiture; AB2 Partially Reclaimed Forfeiture; and AB3 Reclaimed Forfeiture. See Appendix 1, Code Sheet for further definition of these terms.

**Item 23b: State Office.** This code has been added and is optional for Field Office use in identifying specific local State offices.

**Item 29: Identified Violation Data.**

**General:** Changed to read: This item shall be completed for OSM inspections both in primacy and Federal program States (Items 29D & E will not apply in Federal program States). In primacy States, it was formerly completed only during complete standard oversight sample inspections (random samples). Now however, Item 29 must be completed in primacy States for all random sample **and all in-depth review complete and partial inspections** (See SC/SP codes above). Like with a random sample inspection, a complete or partial in-depth review inspection will now require identification and listing of all violations present during the in-depth review inspection **and all violations that were present during the last State complete inspection (LSCI)** based on a review of the LSCI report and observation of violations during the in-depth review inspection that clearly existed during the LSCI. The LSCI is the complete inspection conducted by a State regulatory authority immediately prior to the current Federal inspection.
