SUBJECT: ANSI X12 Transaction 270/271 Changes

I. GENERAL INFORMATION

A. Background

This one-time notification changes CWF mapping requirements for the 271 files. In addition, it makes changes to the eligibility Direct Data Entry (DDE) screens to ensure that the screens are displaying data that complies with the requirements of the Health Insurance Portability and Accountability Act (HIPAA) eligibility standard.

B. Policy:

Eligibility transactions must comply with the Version 4010A1 X12N 270/271 implementation guide adopted as the national standard under HIPAA; therefore Medicare 271 files must meet the business requirements listed below. DDE eligibility screens may not contain data elements unavailable in the 271 and the DDE data content must also comply with 271 coding requirements.
