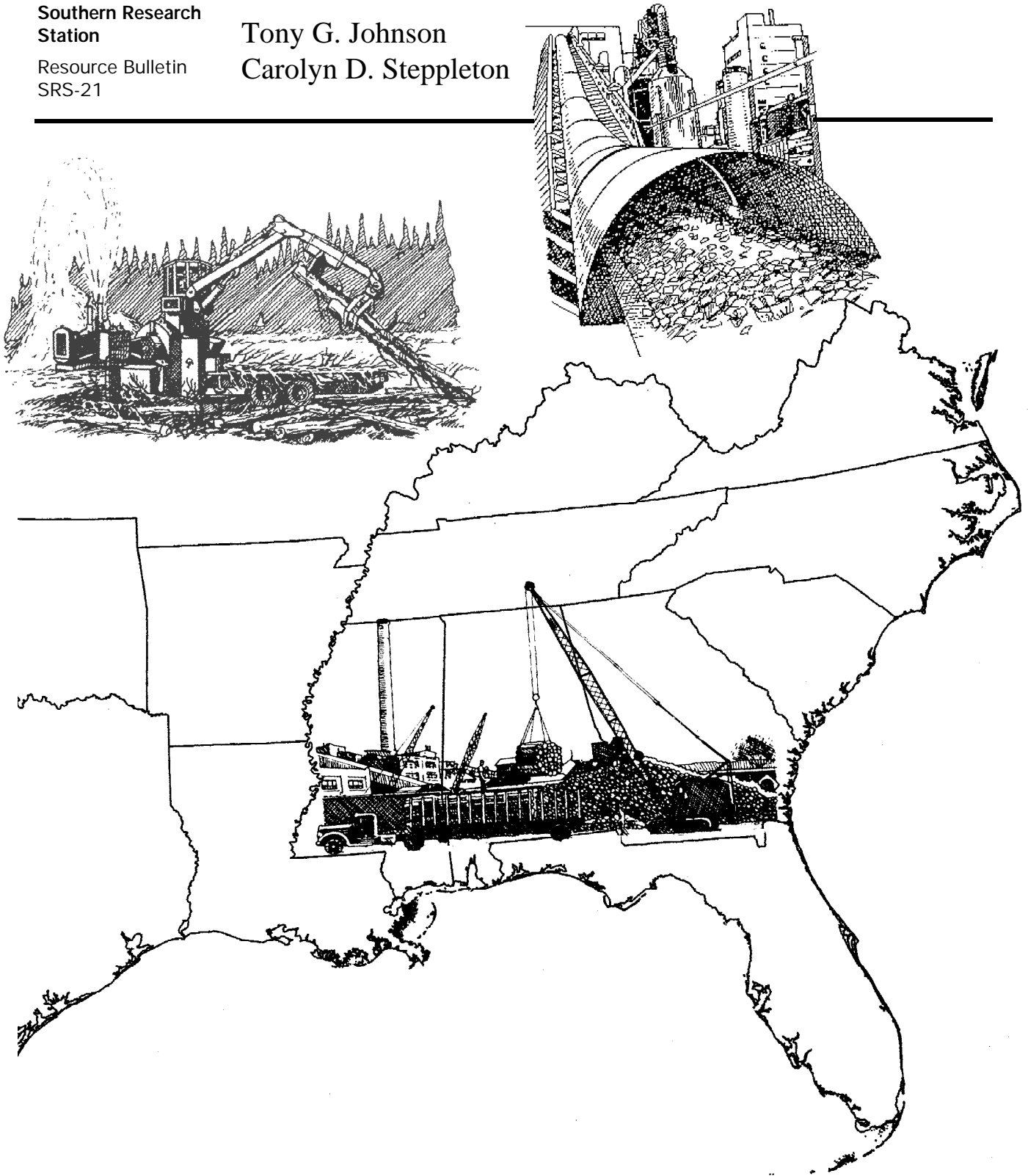

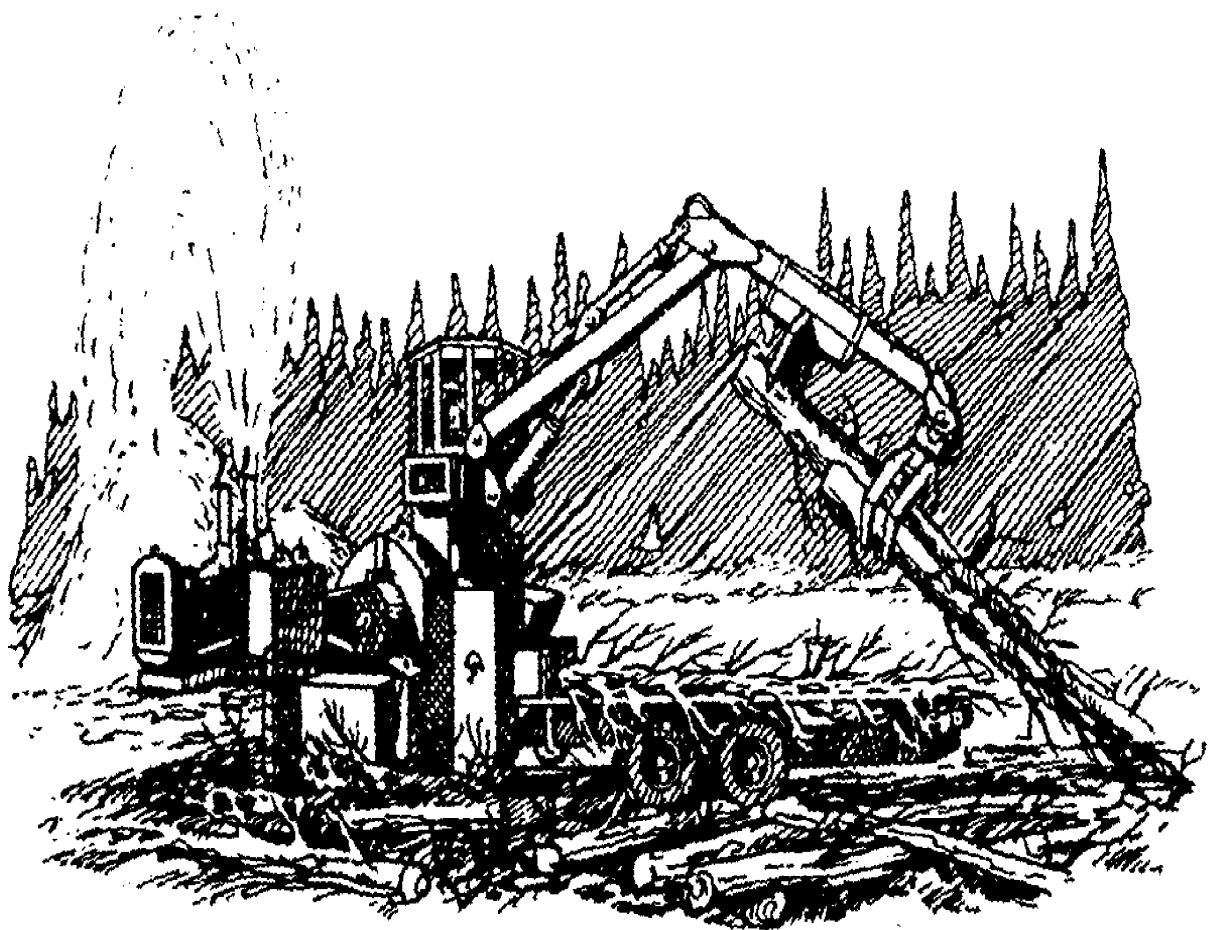

Introduction

This annual publication presents the findings of a 100-percent canvass of pulpmills that draw roundwood or wood residues from the 13 Southern States. Canvass data are compiled, analyzed, and reported annually by the Southern Research Station. Ninety-five of the 105 mills canvassed responded. Past canvass data and other sources of information were used for mills that did not respond. Mill data reported in nonstandard units were converted to standard cords with regional conversion factors. All production figures are reported in cords. Production expressed in equivalent green tons are reported in tables 1, 2, and 7-19.

Pulpwood

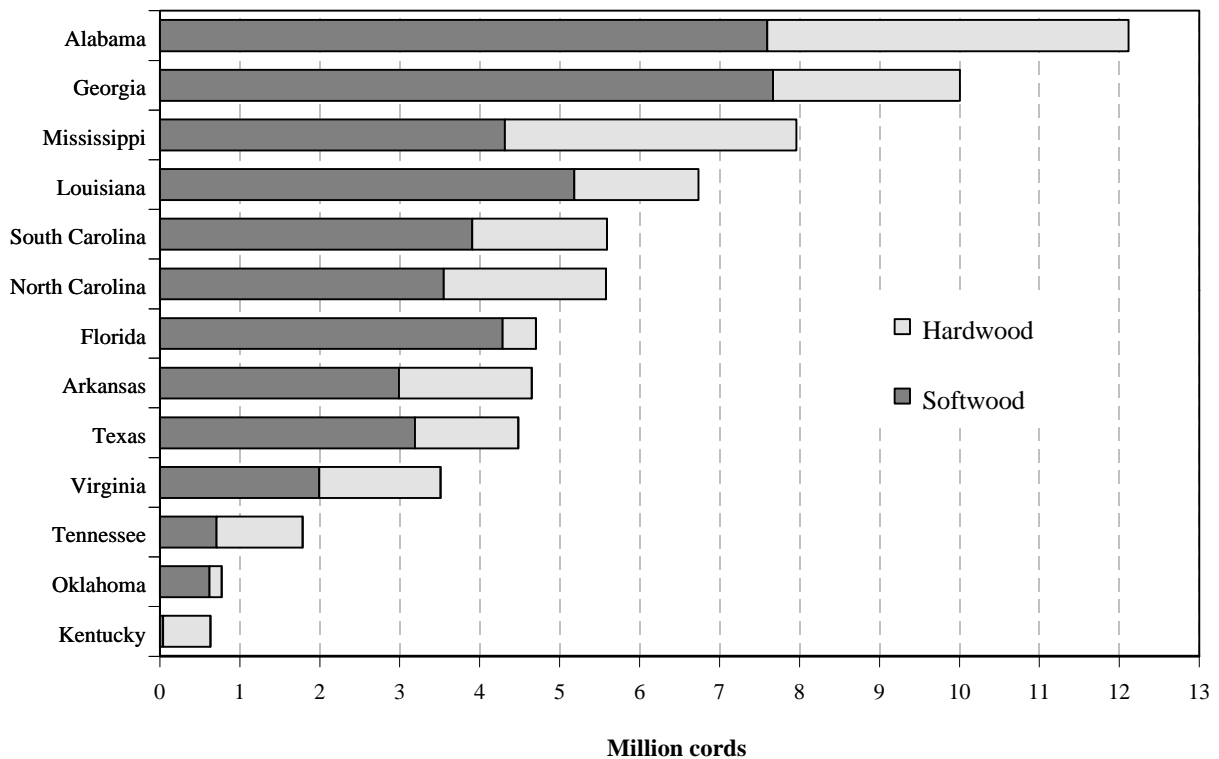


Figure 1—1996 pulpwood production by State and broad species.

After a record-breaking year in 1995, the general upward trend in pulpwood production slowed somewhat. Southern production declined by 6 percent in 1996 to 68.5 million cords, or 181.5 million green tons. In 1996, the South Central Region led in the production of pulpwood. This region supplied 39.1 million cords compared to the Southeast's production of 29.4 million cords (table 1). Alabama continued to lead the South with 12.1 million cords of pulpwood produced in 1996 (fig. 1), an increase of 3 percent from 1995. Georgia's production dropped 10 percent

to 10.0 million cords. Production in Mississippi declined by 5 percent to 8.0 million cords, while Louisiana's production fell by 8 percent to 6.7 million cords. Collectively, these four States accounted for 54 percent of the South's total production. All States except Alabama, Arkansas, and Tennessee reported production declines (table 2). Softwood roundwood and residues combined accounted for two-thirds of the total pulpwood production, while hardwoods accounted for the remainder (table 3).

Roundwood

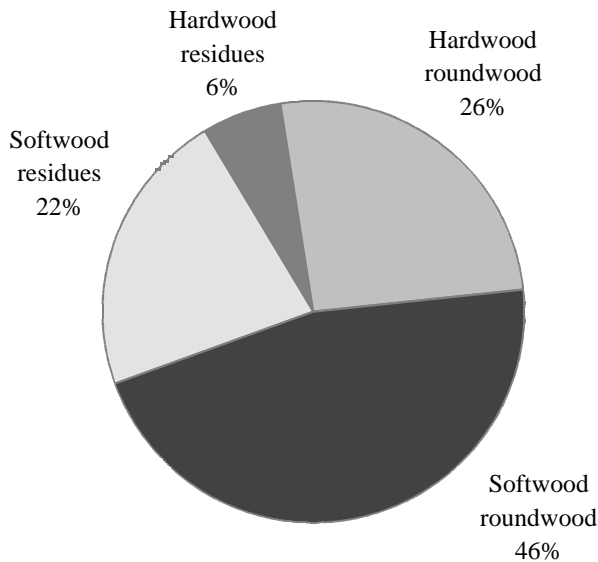


Figure 2—Distribution of total production by roundwood and residues.

Roundwood continues to be the primary fiber source used in pulp manufacture, accounting for 72 percent of the total pulpwood production (fig. 2). Overall, the South's roundwood production was down 5 percent in 1996 to a total of 49.6 million cords (table 4). Softwood accounted for 63 percent of the total roundwood production. Both softwood and hardwood roundwood production declined 4 and 6 percent, respectively. Alabama led in total roundwood production, with 9.8 million cords, and was the leading producer in both softwood and hardwood roundwood, at 5.9 and 3.9 million cords, respectively. Alabama was followed by Georgia with 7.4 million cords total roundwood, Mississippi with 5.7 million cords, and Louisiana with 4.4 million cords. The combined roundwood production for these four States made up 55 percent of the total roundwood production for the Southern States.

Wood Residues

Mills report two types of receipts: (1) roundwood and (2) wood residues. The second category is primarily chips. An unknown proportion of the residue was chipped in the woods or was received at a primary processor (i.e., sawmill or veneer mill) as roundwood and subsequently chipped. Thus, an unknown proportion of the wood chips received at pulpmills as residues should be treated as roundwood because it was not a byproduct of the milling process. However, these data are only obtained from a complete canvass of all commodities for each State and are not available for this report. Notwithstanding, in 1996, wood residue production in the South declined 8 percent to 19.0 million cords (table 5). More than three-fourths of the wood residues produced were softwoods. Chipped residues accounted for almost all the residue produced (table 6). Georgia led all States in the production of wood residues at 2.6 million cords, followed by Louisiana and Alabama with 2.4 and 2.3 million cords, respectively. Only Alabama showed an increase in the production of wood residues in 1996. The South Central Region led the Southeast in wood residue production, supplying 60 percent of the total residue volume.

Parish or County Production

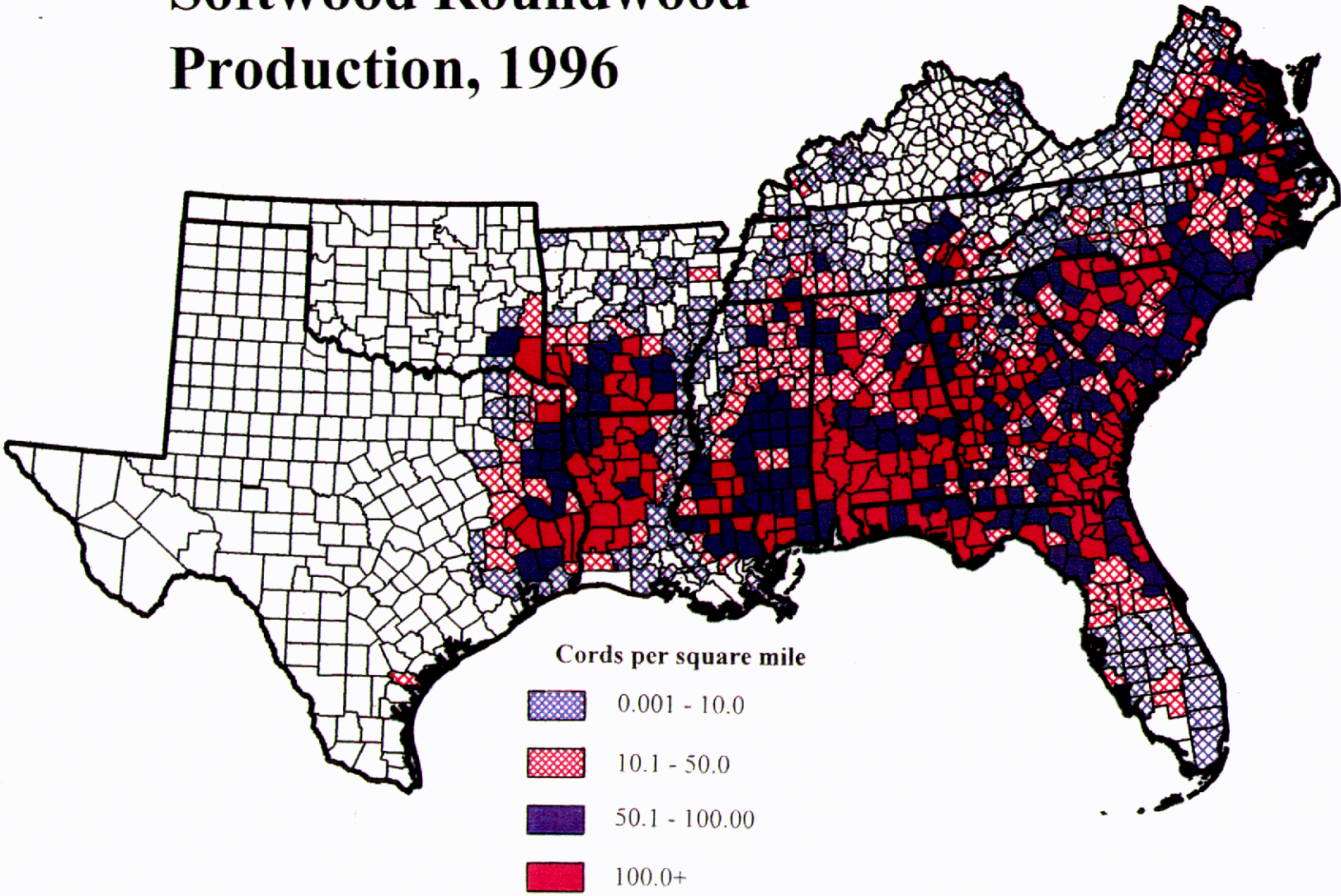


Figure 3—Softwood roundwood production in the South by county or parish, 1996.

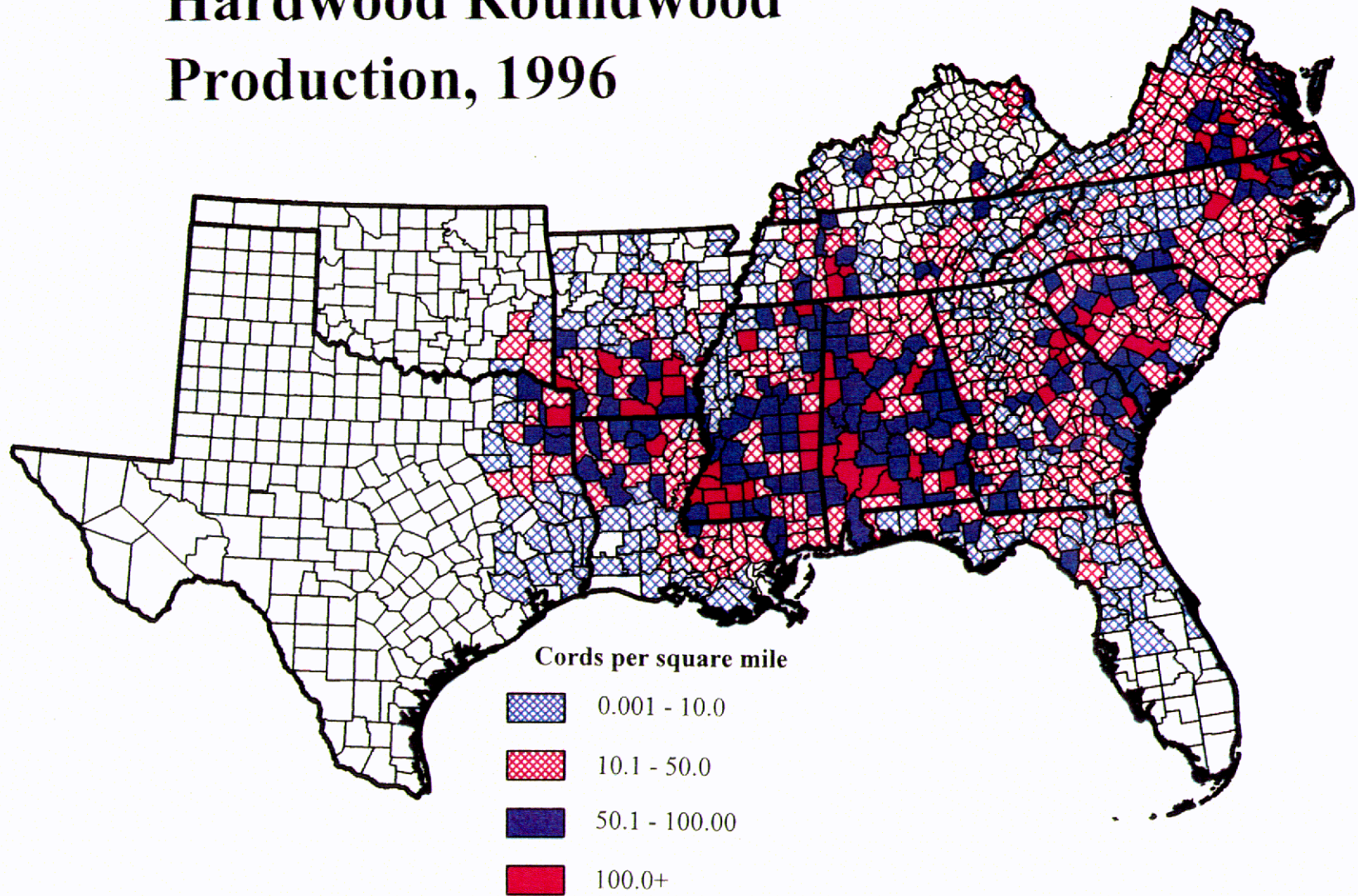


Figure 4—Hardwood roundwood production in the South by county or parish, 1996.

Tables 7-19 report parish (hereafter referred to as county) and county patterns of roundwood pulpwood production. Wood residues are not included in these figures because the county of origin for the residues is difficult, if not impossible, to determine. Of the 1,002 counties encompassed by the Southern Region, 901 counties produced either softwood or hardwood roundwood. Eighteen of

the 901 producing counties harvested more than 250,000 cords of both softwood and hardwood roundwood combined. Most of these counties were concentrated in Alabama. Fifteen percent, or 135 counties across the South, had roundwood production ranging between 100,000 and 250,000 cords. These counties were fairly evenly distributed across the South. The remaining counties had production of less than 100,000 cords. Figures 3 and 4 display softwood and hardwood roundwood production in cords per square mile, rather than total cord production by county, as has been shown in past reports. This method discounts county size and presents a more equitable display of production. The counties in red are those with production of more than 100 cords per square mile. For softwoods, 191 counties across the South had production of more than 100 cords per square mile, while 55 counties had hardwood production in that range (see tabulation below).

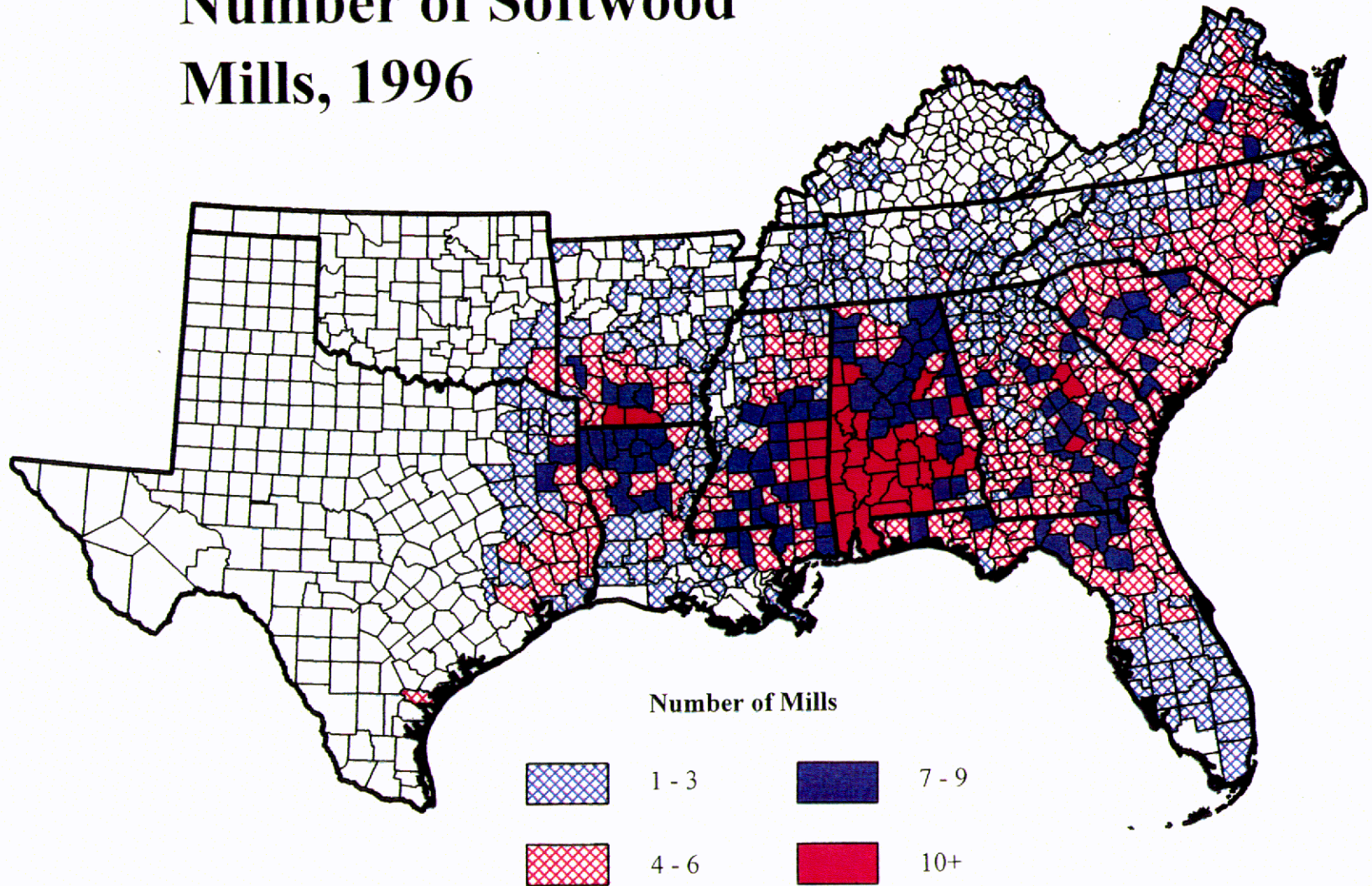


Figure 5—Number of mills competing for softwood roundwood by county or parish, 1996.

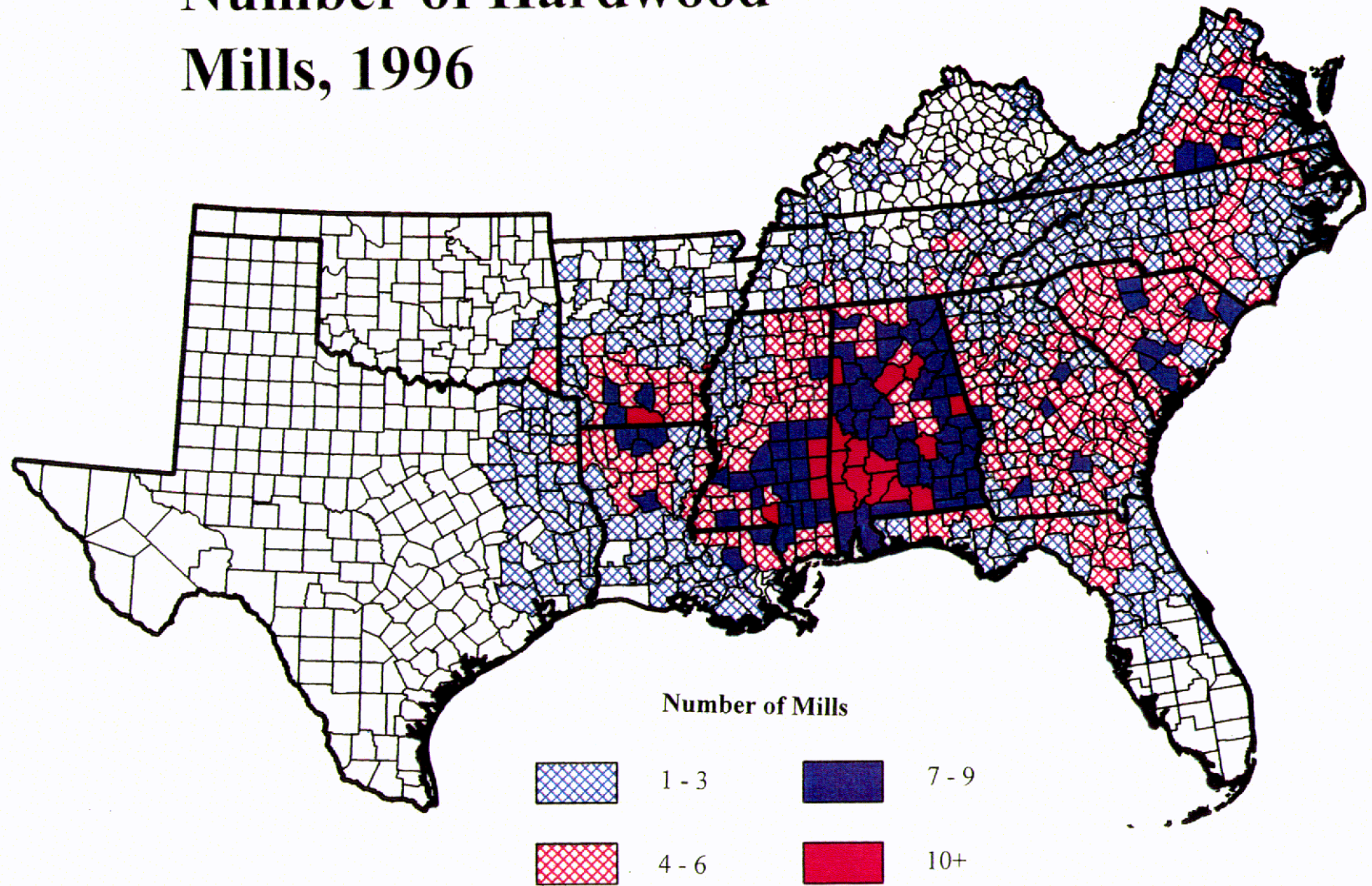


Figure 6—Number of mills competing for hardwood roundwood by county or parish, 1996.

A barometer for degree of competition is the number of mills procuring wood in a county (figs. 5 and 6). In 341 of the producing counties, or 38 percent of the total, 1 to 3 mills were actively procuring both softwood and hardwood roundwood (see tabulation below). In 288 counties, 4 to 6 mills were actively procuring wood; and in the remaining 272 counties, or 30 percent of the total, 7 or more mills were active.

Hardwood Roundwood Production, 1996

Number of Softwood Mills, 1996

Number of Hardwood Mills, 1996

Roundwood Movement

Tables 20 and 21 show the softwood and hardwood roundwood movement for the Southeast and South Central Regions. Because this is a relatively new addition to the pulpwood production report, a brief explanation will help the reader use these tables. The numbers inside the frames represent roundwood that was harvested and retained for processing within each State. The numbers in rows to the left or right of the retained figures represent wood exported to the other States. Therefore, the retained figure added to the wood exported out of State totals the roundwood production for the State. The numbers in columns above or below the retained figures represent wood that was imported from other States. The retained figure plus the wood imported from other States represents roundwood receipts or the amount of roundwood processed by the mills in that State. The Southeast was a net importer of both softwood and hardwood roundwood, with imports exceeding exports by 732,000 cords (tables 20 and 21). For softwood and hardwood combined, the South Central Region was a net exporter of roundwood, with exports exceeding imports by 247,000 cords.

Mills

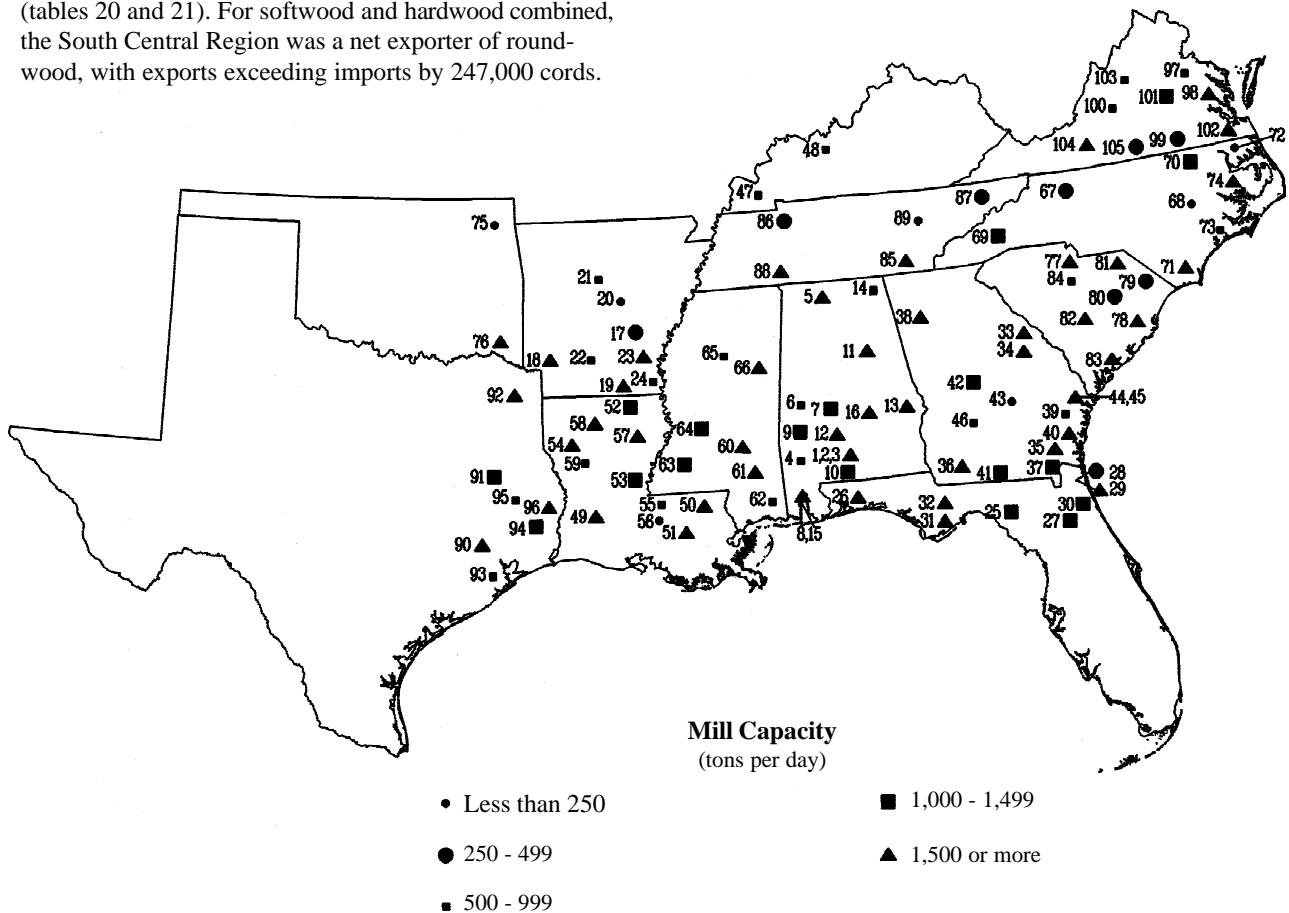


Figure 7—1996 capacity of southern pulpmills operating and drawing wood from the 13 Southern States. Numerals are coded to table 22.

In 1996, 105 southern pulpmills were operating and drawing wood from the 13 Southern States (fig. 7). Total southern mill pulping capacity declined slightly, to 137,160 tons per day. Southern mills still account for more than two-thirds of the Nation's total pulping capacity. Daily capacity of individual mills ranged from 50 tons to more than 3,200 tons. The average mill can produce 1,306 tons of pulp daily, compared to 1,161 tons in 1985. The sulfate process dominates the pulping industry, accounting for 85 percent of the southern mill capacity. Ten percent of the capacity is groundwood or other mechanical processes, 4 percent semi-chemical, and 1 percent soda and other chemical processes (table 22). At the 1996 production level and pulping capacity, southern mills operated at about 89 percent of capacity. Alabama and Georgia continued to lead the South in the number of mills operating, with 16 and 14 mills, respectively.

Alabama led in pulping capacity with 22,205 tons per day, to Georgia's 22,130 tons per day (see tabulation below). In addition, three pulpmills outside the Southern Region drew wood from the South in 1996 (table 23).

Trends

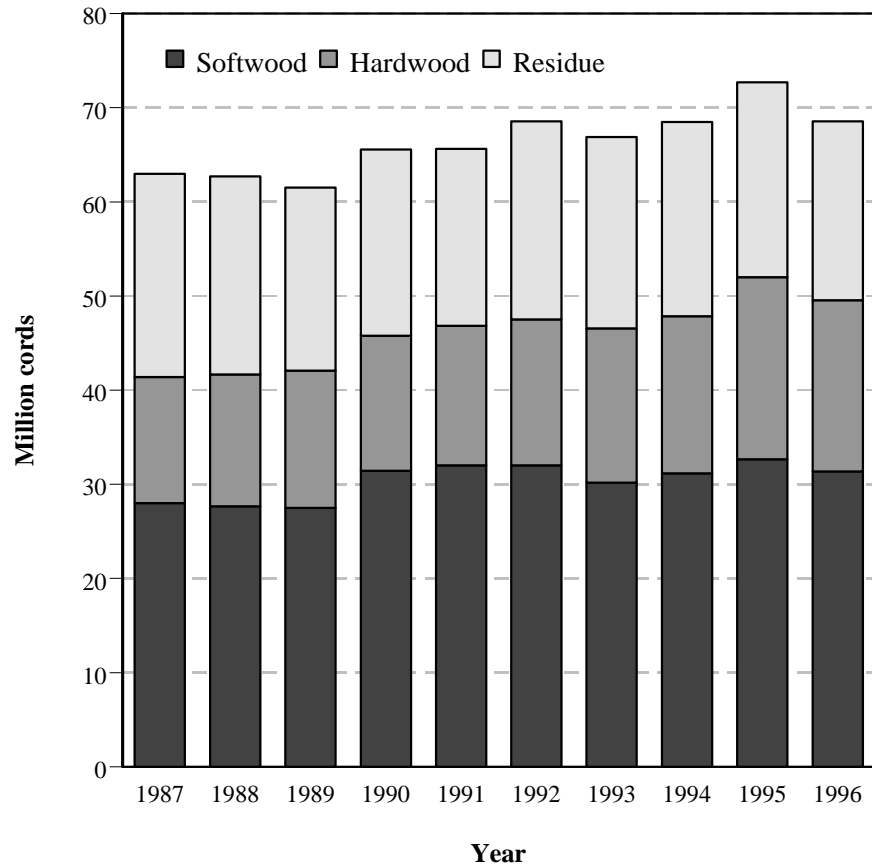


Figure 8—Southern pulpwood production, 1987-96.

From 1987 through 1996, southern pulpwood production increased by 9 percent, from 63.0 to 68.5 million cords (fig. 8). During the same period, roundwood pulpwood production increased from 41.4 to 49.6 million cords, a 20-percent gain. Between 1987 and 1996, softwood roundwood production increased 12 percent, while hardwood roundwood production increased 36 percent. The production of wood residues dropped 12 percent, from 21.6 million cords in 1987 to 19.0 million cords in 1996. For the 10-year period, wood residues as a proportion of total production peaked in 1987 at 34 percent. However, wood residues continue to be an important source of fiber for the pulpwood industry in the South, accounting for 28 percent of all pulpwood production in 1996.

In 1996, the South's production of pulpwood decreased 6 percent to 68.5 million cords. Roundwood production decreased to 49.6 million cords and accounted for 72 percent of the total pulpwood production. The use of wood residue declined to 19.0 million cords. Alabama leads the South in total production, number of mills, and pulping capacity. Currently, 105 mills are operating and drawing wood from the 13 Southern States. Southern mills' pulping capacity of 137,160 tons per day accounts for more than two-thirds of the Nation's total pulping capacity.
