

**List of Speakers and Tentative Schedule  
Public Hearing to Discuss EPA's Proposed BART Guidelines  
Chicago, Illinois. Monday, August 27, 2001**

As we noted in the Federal Register notice for the BART guidelines, EPA is providing the following table to indicate the tentative order for speakers at the August 27 public hearing. We appreciate your understanding that there may be changes to the schedule as the day progresses.

We plan on starting the hearing at 10:00 am. We will break for lunch from 12:30 - 1:30.

Currently, we have 56 speakers signed up, with a few speakers specifically requesting an evening session to provide opportunities for people who cannot testify during working hours.

Each speaker will be given 5 minutes. EPA's experience has been that there will be about 8-12 people testifying for each hour of the hearing. Thus, we estimate the following rough schedule to give you a ballpark idea of when you are likely to testify:
