TREASURY INTERNATIONAL CAPITAL DATA FOR JULY

Treasury International Capital (TIC) data for July are released today and posted on the U.S. Treasury web site (www.treas.gov/tic). The next release date, which will report on data for August, is scheduled for October 18, 2004.

Long-Term Domestic Securities

Gross purchases of domestic securities by foreigners were \$1,310.1 billion in July, exceeding gross sales of domestic securities by foreigners of \$1,230.0 billion during the same month.

Foreign purchases of domestic securities reached \$80.1 billion on a net basis in July, relative to \$85.3 billion during the previous month. Private net flows reached \$73.8 billion in July. Net private purchases of Treasury Bonds and Notes fell to \$18.3 billion from \$23.0 billion the preceding month. Net private purchases of Government Agency Bonds were \$18.7 billion, up from \$15.3 billion the previous month. Net private purchases of Corporate Bonds rose to \$27.0 billion from \$26.5 billion the previous month. Net private purchases of Equities increased to \$9.7 billion from \$2.2 billion.

Official net purchases of U.S. securities were \$6.4 billion in July, relative to \$18.3 billion in June. Official net purchases of Treasury Bonds and Notes of \$4.1 billion accounted for the bulk of official inflows in July, down from \$17.5 billion the previous month.

Long-Term Foreign Securities

Gross purchases of foreign securities owned by U.S. residents were \$286.9 billion in July, relative to gross sales of foreign securities to U.S. residents of \$303.1 billion during the same month.

Gross sales of foreign securities to U.S. residents exceeded purchases by \$16.1 billion, highlighting a net U.S. acquisition of \$8.8 billion in Foreign Equities and \$7.3 billion in Foreign Bonds.

Net Long-Term Securities Flows

Net foreign purchases of both domestic and foreign long-term securities from U.S. residents were \$64.0 billion in July compared with \$74.0 billion in June. Net foreign purchases of long-term securities were \$776.9 billion in the 12-months through July 2004 as compared to \$699.4 billion during the twelve months through July 2003.
