




DOE Now on Track






Cases Waiting Processing






DOE's Path Forward is Credible, Comprehensive, and Eliminates the Backlog in 2006






DOE's Plan Eliminates the Backlog in CY 2006

NIOSH Provides DOE with Physician Panel Nominees


•NIOSH has provided DOE with 250 physician panel nominees

Applicants Applying For Work Comp


Workers' Compensation Payout as of 7/31/04
