A 10-year research agenda has been created by the Interagency Autism Coordinating Committee (IACC), a group of government agencies and parents directed by Congress to coordinate autism activities throughout the federal government. CDC invites you to join us for a listening session and provide feedback on the portion of that agenda that deals specifically with the autism activities of CDC, which include

- Monitoring the prevalence of autism to determine trends over time and identify those groups at higher risk.
- Conducting public health research on potential causes and other issues, including investigations into potential environmental and chemical influences.
- Educating the public about the importance of early screening and intervention for children with autism.

### FROM THE NORTH (RENO)


### FROM THE SOUTH (STOCKTON)

### FROM THE EAST (PLACERVILLE)

Take Hwy. 50 to the Stockton Blvd. exit. Turn LEFT on Stockton Blvd. and then LEFT on 2nd Avenue. Go through stop sign straight, 2nd becomes 50th Street.

## FROM THE WEST (DAVIS SAN FRANCISCO)

Take Hwy 80 (merges into Hwy. 50). Exit on 34th Street. Turn LEFT on 34th Street, RIGHT on T Street, RIGHT on Stockton Blvd., and LEFT on 2nd Avenue. Go through stop sign straight, 2nd becomes 50th Street.
