Election Day is fast approaching. By now, you should have requested and hopefully received your absentee ballot. So that your ballot arrives in time to be counted, please mail it right away or bring it to the American Citizen Services (ACS) Branch at the Embassy and we will mail it for you.

# Too Late to Request an Absentee Ballot?

Each state sets its own rules regarding the election calendar. For most states, the deadline has already passed to request an absentee ballot. However, some states will still allow you to request an absentee ballot. To check your individual state's deadline, please go to the Federal Voting Assistance Program (FVAP) Main Page http://www.fvap.gov/.

#### Ballot Hasn't Arrived? Use the Write-In Ballot (FWAB)

If you requested an absentee ballot, but have not received one, you may vote by using a Federal Write-in Absentee Ballot (FWAB), which is available from the American Citizen Services (ACS) Branch at the Embassy in Seoul. The FWAB is only valid when a regular ballot from the state or territory has already been requested, in a timely manner, and has not been received. # You Mailed the Write-in then Received the Actual Ballot?

If you send in an FWAB and then receive your actual absentee ballot, you should vote using the absentee ballot and return it to meet your state's ballot receipt deadline. The election official will match up the two forms and discard the FWAB.

### Deadline to Mail Absentee Ballot

Most states will accept your absentee ballot right up to, or even after, the election on November 2. To see your state's calendar for accepting absentee ballots, please go to http://www.fvap.gov/ . Several states have recently extended their deadlines. For instance,

## FedEx Will Mail your Ballot for Free

To help ensure timely arrival of your absentee ballot, Federal Express has agreed to ship absentee ballots to your local election clerk's office at no cost to you. This service will be available until November 1, 2004. There is no pick-up service. Ballots may be dropped off at any FedEx service center, station, or ship center (for a listing of FedEx offices, please see http://www.fedexapac.com/kr\_english/dropoff/ ).
