AFMAN 23-110, Volume 2, Part 2, Chapter 26, is supplemented as follows:

SUMMARY OF REVISIONS

This document is substantially revised and must be completely reviewed. It updates office symbols as a result of the Chief of Staff Logistics review.

26.31.4.1. In accordance with AFMAN 23-110, Vol 1, Part One, Chapter 12, Section D, AETC Sup 1, approval for temporary mission support kits (TMSK) is delegated to the chief of supply (COS) when the squadron supports routine (generally one-time) exercises and deployments. Permanent mission support kits (PMSK) are authorized when the squadron supports recurring exercises and deployments. Squadrons with PMSKs will provide written justification on an annual basis to HQ AETC/LGRW.

26.44.3.1. AETC units will use Air Force tariff sizing concept in any configuration for all bags; for example, for each 100 bags, maintain approximate quantity of 1 extra-small (1 percent), 11 small (11 percent), 59 medium (59 percent), 24 large (24 percent) and 5 extra-large (5 percent). Deviation from this policy requires written approval from HQ AETC/LGRWE. Recommended tariff guides are provided in Table 26F2.3 (Added)(AETC) and Table 26F3.4 (Added)(AETC).

26.44.3.2. See Attachment 26F-4 (Added)(AETC) for gas mask support kit contents. A listing of national stock numbers (NSN) for various items in mobility bags is accessible on the HQ AETC/LGR web site at https://www.aetc.af.mil/lg/lgr/lgrw. In addition, AETC units will maintain a current copy of AETC's War and Mobilization Plan (WMP) III and all applicable amendments to identify unit type code tasking (obtainable from wing plans office [XP].)

26.45.1. The COS or supply service provider will maintain all C-1 bags. HQ AETC/LGRWE must approve any deviations to this policy. Using activity has the option to maintain its A and B bags, provided there is a

written agreement between the COS and the using activity. If bags are maintained by the using activity, this activity is responsible for the management of mobility bags including providing secure storage, issue, and receipt. *NOTE:* All units that maintain bags must have ready access to the most current AFMAN 23-110, Volume 2, Part Two, Chapter 26 and all applicable supplements.

26.45.3. The Mobility Inventory Control and Accountability System (MICAS) will be used for the management and control of all mobility bags. (*NOTE:* Units must notify HQ AETC/LGRWE if this system becomes inoperable for more than 48 hours. Submit any necessary reports in accordance with the MICAS roll-up program using EXCEL [a trademark of the Microsoft Corporation]. Mobility sections will maintain a complete Report to Congress in hard copy. Assets will be divided by bag type in accordance with this supplement (examples are located at <u>https://www.aetc.af.mil/lg/lgr/lgrw</u>.)

26.46.1. Units will review mobility bag authorizations and inventory quarterly no later than the 10th day of March, June, September and December, and report to the base supply, mobility section, to update the MICAS database. The COS will consolidate the data and forward one inventory report to HQ AETC/LGRWE no later than the 25th day of March, June, September and December, or as required. Units will contact HQ AETC/LGRWE before establishing due-outs to determine the availability of excesses within the command to fill shortages.

26.46.1.1. Units are authorized up to a 10 percent safety level.

26.46.1.2. Units are authorized up to a 20 percent safety level.

NATIONAL STOCK NUMBERS (NSN) ARTHROPOD COUNTERMEASURES

26F5.1. (Added)(AETC) Recommended Arthropod Countermeasure NSN. Items in Table 26F5.1 (Added)(AETC) are required for personnel deploying to areas where there is a risk of arthropod-borne diseases. Examples of these diseases include malaria, yellow fever, dengue and leishmaniasis. Items are AOR specific and chiefs of supply should consider if investment is warranted or if overnight re-supply from depot or local sources will suffice. COS may want to maintain enough to deploy at least 10 people for short-notice deployments or coordinate actions to have National Industries for the Blind Retail Outlets maintain assets. If maintained by COS, items would be maintained in mobility sections or designated area determined by the COS. Reimbursement may be accomplished by requisitioning assets using applicable contingency ESP code.
