

Accessibility



Grand Teton National Park and the John D. Rockefeller, Jr., Memorial Parkway offer a wide range of accessible facilities. Many of the park concessioners also are able to accommodate people of differing abilities. This handout provides basic information about accessible facilities. Please contact park rangers or concession staff for further information.

Golden Access Passport

The Golden Access Passport is available free to American citizens who have been medically determined to have a permanent disability. Golden Access Passport holders are allowed free admission to all national parks and other federal recreation areas for

themselves and those accompanying them in the same vehicle. Camping fees are half price. Golden Access Passports are available at all National Park Service entrance stations and many visitor centers.

Concession Facilities

Most services within the park including food, lodging, and activities can accommodate people of differing abilities. In some cases facilities are Americans with Disabilities Act (ADA) compliant as accessible, in other cases the concessioners will work with individuals to provide accommodations. Jackson Lake Lodge

The lodge features 19 fully accessible guest rooms. Parking, registration, main lobby, decks and restrooms are fully accessible. A portable strobe and a TDD kit are available in the reservation office. Two restaurants on site, the Mural Room and the Blue Heron Lounge are wheelchair accessible. The Pioneer Grill is not accessible but its menu is available in the Mural Room for disabled patrons.

Jenny Lake Lodge

This facility has 2 accessible guest rooms (without roll in showers). The lobby, registration area, restaurant, and restrooms are fully accessible.

Colter Bay Village

The store, marina, restaurant, and cabin office are all fully accessible.

Flagg Ranch

Flagg Ranch has 2 fully accessible rooms and 3 mostly accessible rooms with no rails on the tubs

Signal Mountain Lodge

The convenience store, restaurant, and registration building are wheelchair compliant. Six cabins have no stairs but none of the room interiors are ADA compliant.

Leeks Marina

The restaurant and bathroom are accessible; the marina is not.

Triangle X Ranch

There is one fully ADA accessible cabin with a ramp. The main house has a ramp and wheelchair accessible public bathroom.

Jenny Lake Boating

The eastside dock and bridge are wheelchair accessible. Shuttle boats are ADA compliant. The westside dock is not accessible.

Activities

Although none of the concessioners offering activities such as river trips, horseback riding, and mountain climbing are ADA compliant, all concessioners will work with interested visitors to make necessary accommodations.

Hiking Trails

Hiking trails in Grand Teton National Park offer varying degrees of difficulty and challenge. Some trails are easily accessible, like those at Jenny Lake, String Lake and Colter Bay. Wide, paved trails with gentle slopes lead to the shore of Jenny Lake. Stone retaining walls provide built-in benches near the lakeshore along the 3/4 mile loop. A level, paved trail, dotted with rustic log benches, follows the String Lake shoreline. Interpretive signs describe the

formation of glacial lakes. The Colter Bay Lakeshore Trail, along the eastern shore of Jackson Lake, is paved for 1/3 of a mile beginning at the marina. Easiest access to this trail is through the Colter Bay amphitheater, just north of the visitor center. An entirely accessible trail, located at the south end of the Jackson Lake dam, offers tremendous views of Jackson Lake and the Teton Range. Other trails in the park may be accessible with a higher level of difficulty.
