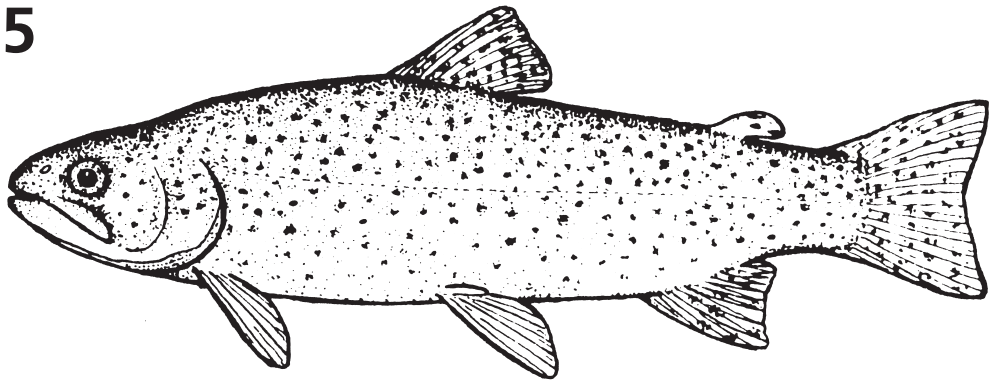




Fishing 2004/2005



Licenses

A Wyoming fishing license is required; a \$10.00 Conservation Stamp is required to accompany all licenses except the one-day license.

Resident License	\$18.00
One-Day	\$3.00
Youth (14-17)	\$3.00
Under 14 (creel limit applies)	no license needed

Non-resident License	\$75.00
One-Day	\$10.00
Youth (14-17)	\$15.00

Non-residents under 14, accompanied by a person possessing a valid Wyoming fishing license, may fish free. Fish caught by

persons under 14 are included in the licensed person's creel limit.

Prohibited Actions

- Using or possessing fish eggs (real or artificial) or corn for bait.
- Chumming or placing food or other substances in any waters to feed or attract fish.
- Digging for or collecting any bait.
- Snagging, archery, and speargun fishing.
- Fishing from Jackson Lake Dam, boat docks, any bridge used by vehicles, or within the limits of designated mooring areas and swimming beaches.
- Any fish that anglers choose not to keep must be carefully and immediately returned to the waters from which they were taken.

Season Dates

Waters within Grand Teton National Park are open to fishing year-round with the following exceptions.

Jackson Lake

- Closed to fishing 10/01 - 10/31.

Snake River Proper

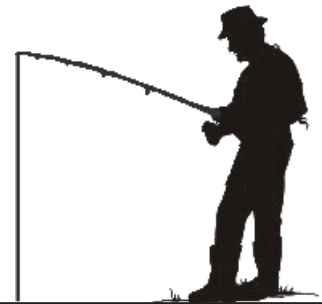
- Open to catch and release fishing only 11/1 - 03/31. All fish must be carefully and immediately released to the waters from which they were taken.

Buffalo Fork and Gros Ventre Rivers, Pacific Creek, and all tributaries upstream from Jackson Lake Dam

- Closed to fishing 11/01 - 03/31

All Snake River tributaries below Jackson Lake Dam (except Buffalo Fork and Gros Ventre Rivers and Pacific Creek)

- Closed to fishing 11/01-07/31



Legal Tackle

Legal Fishing Tackle

Two rods or poles may be used. Each line may have no more than three single or treble hooks, flies, or lures attached. The angler must be in attendance.

Flies, Lures, and Bait

The use or possession of any fish, fish eggs (real or artificial), fish parts, or corn for bait is prohibited in all park and parkway waters except Jackson Lake. On Jackson Lake and along the shores of Jackson Lake the

following dead, non-game fish may be used or possessed as bait: redbreast shiner, speckled dace, longnose dace, Piute sculpin, mottled sculpin, Utah chub, Utah sucker, bluehead sucker, and mountain sucker.

Snake River from the gauging station 1,000 feet below Jackson Lake Dam to Wilson Bridge (WY Highway 22 bridge) and all Snake River tributaries below Jackson Lake Dam (except Buffalo Fork and Gros Ventre Rivers)

- Only artificial flies and lures may be used.

Creel and Size Limits

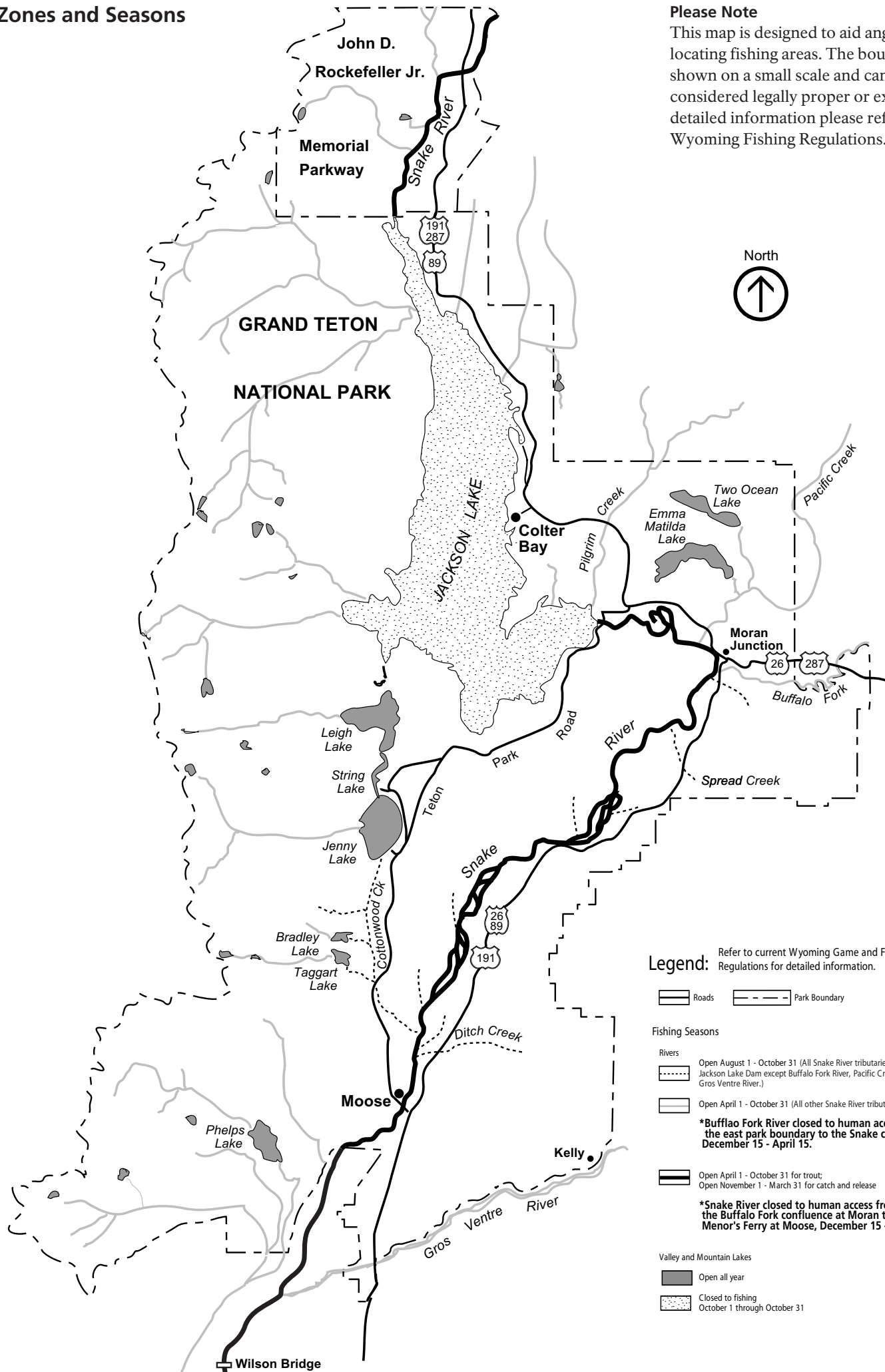
- Limit is 6 trout per day or in possession, no more than three shall be cutthroat trout.
- Only one cutthroat trout may exceed 12 inches.
- Only one trout may exceed 20 inches.

The following exception applies:

Jackson Lake

- Only 1 trout may exceed 24 inches.

Protecting Park Resources

Wildlife

- Bald eagle nesting areas along the Snake River are signed and closed to riverbank use. Do not fish near any nest as birds are susceptible to disturbance while nesting.
- Aquatic nuisance species are an increasing concern in Grand Teton National. Protect park waterways and native fish by learning how you can prevent the spread of exotics. Refer to page 8 of the Wyoming State Fishing Regulations for specific practices.

Closed Areas

Areas closed to fishing: Snake River 150 feet below Jackson Lake Dam, Swan Lake, Sawmill Ponds, Moose Pond, Hedricks Pond, Christian Ponds, Cottonwood Creek from the outlet of Jenny Lake downstream to the second bridge (south of the Jenny Lake parking area).

Fish Cleaning and Disposal

To prevent whirling disease put fish parts in the garbage. Do not dispose of fish heads, skeletons, or entrails in any waters.
