The U.S. Department of Agriculture (USDA) invites offers to sell frozen fruit as indicated below and per the Announcement for distribution to schools and other domestic food assistance programs. Offers are due by 1 p.m., Central time, Friday, September 10, 2004. Acceptances will be announced by midnight, September 24, 2004. Deliveries are to be made from December 1, 2004 through April 30, 2005.

- All invitations with orders for the state of New York, must have the pack date stamped on the outside of each carton. The pack date should be annotated as per the following example: (05/01/2003). Orders for the state of New York requiring the special marking will be indicated by (**). This applies to New York orders "Only," if and when they appear on an invitation.
- No offer will be made to 8(a) vendors on this invitation other than the 8(a) vendor who has an IDIQ contract for this commodity.
- On "BKLYN/CEN ISLIP NY" destinations, shippers are instructed to call the
 contact person on the Notice to Deliver first prior to making an appointment,
 so that they can be directed to which warehouse they will ship the product.

Bids must be submitted electronically via the Domestic Electronic Bid Entry System (DEBES) on the internet. Offerors who submit bids using other than DEBES, will be deemed non-responsive.
