The U.S. Department of Agriculture (USDA) invites offers to sell canned juice as indicated below and per the Announcement for distribution to the needy family and other domestic food assistance programs. Offers are due by **11:00 a.m., Central time, Friday, September 24, 2004**. Acceptances will be announced by midnight, September 29, 2004. Deliveries are to be made from January 1, 2005 through April 30, 2005.

Note:

- (1) Manufacturer's own commercially packaged and labeled product is acceptable as long as it meets all of the requirements of the Food and Drug Administration and contains an identification code that allows for traceability of the product (NO tray packs).
- (2) No offer will be made to 8(a) vendors on this invitation.
- (3) All orders for the state of New York (NY) must have the pack date stamped on the outside of each carton. Orders for the state of NY are indicated by (**).
- (4) On "BKLYN/CEN ISLIP NY" destinations, shippers are instructed to call the contact person on the Notice to Deliver first prior to making an appointment, so that they can be directed to which warehouse they will ship the product.

Vendors doing business with USDA are required to be registered in the Central Contractor Registration (CCR) system before being awarded contracts. If the



Offeror is not registered in the CCR database within 48 hours after bid opening, offers will be deemed non-responsive.

Assignees shall be separately registered in the CCR database. Once a contract has been awarded, the Contractor shall not change the name or address for Electronic Funds Transfer (EFT) payments in the CCR record for the purpose of assignment of claims.
