LET'S TRY THAT AGAIN.

GOOD MORNING.

>> GOOD MORNING.

>> HOW IS EVERYONE THIS MORNING?

MY NAME IS CLAUDE ALLEN.

I'M FROM THE GOVERNMENT.

I'M HERE TO HELP YOU THIS MORNING.

NO, ACTUALLY IT'S MY PRIVILEGE TO WELCOME YOU ALL HERE THIS MORNING AND THANK YOU FOR COMING TO THIS VERY IMPORTANT AND HISTORIC EVENT.

I AM CLAUDE ALLEN, AS I SAID EARLIER, AND I AM THE DEPUTY SECRETARY FOR HEALTH AND HUMAN SERVICES.

AND IT IS MY DISTINCT HONOR AND PRIVILEGE TO HOST TODAY'S MEETING, ALONG WITH MY COLLEAGUES FROM NINE OTHER FEDERAL AGENCIES, THE OFFICE OF MANAGEMENT AND BUDGET AND THE WHITE HOUSE.

AT THIS TIME, I WOULD LIKE TO JUST SHARE WITH YOU A COUPLE OF THOUGHTS.

SECRETARY THOMPSON SENDS HIS REGRETS THAT HE COULD NOT BE HERE WITH US THIS MORNING TO LAUNCH THIS VERY IMPORTANT EVENT.

BUT HE WAS CALLED BY CONGRESS AT THE LAST MINUTE TO TESTIFY THIS MORNING ON THE STEM CELL RESEARCH ISSUE.

THE SECRETARY WILL BE JOINING US LATER THIS AFTERNOON, AND HE WILL BRING SOME CONCLUDING REMARKS. AND HE WILL ALSO WANT TO HEAR YOUR COMMENTS AND YOUR CONCERNS AS WE ADDRESS THIS NEW FREEDOM INITIATIVE.

HE SHOULD BE WITH US AROUND 4:00, 4:30, AND WE'LL CLOSE OUT SO I WANT TO ENCOURAGE YOU TO REMAIN HERE. HE WOULD WANT TO INTERACT WITH YOU PERSONALLY AND TALK WITH AS WELL.

ADDITIONALLY, PRESIDENT BUSH SENDS HIS REGRETS THAT HE COULD NOT BE HERE WITH YOU TODAY.

WE HAVE A VISITOR FROM -- OUR NEIGHBOR FROM THE SOUTH, THE PRESIDENT VISITING FROM MEXICO.

AND PRESIDENT BUSH IS ENTERTAINING HIM TODAY.

AND HE IS VERY BUSY WITH A VERY HECTIC SCHEDULE IN DEALING WITH OUR FOREIGN VISITORS.

HE HAS, HOWEVER, SENT A LETTER OF WELCOME THAT I WOULD LIKE TO READ TO YOU AT THIS TIME.

PRESIDENT BUSH SAYS, "I AM PLEASED TO SEND WARM GREETINGS TO ALL THOSE ATTENDING AND PARTICIPATING IN THE NATIONAL LISTENING SESSION ON COMMUNITY-BASED ALTERNATIVES WITH PEOPLE WITH DISABILITIES.

YOUR EXPERIENCES AND PERSPECTIVES ARE CRITICAL TO UUNDERSTANDING AND SOLVING THE CHALLENGES THAT AFFECT THE LIVES OF MILLIONS OF AMERICANS WITH DISABILITIES. THE EXECUTIVE ORDER I ISSUED IN JUNE DIRECTED MY CABINET MEMBERS TO SOLICIT AND LISTEN TO THE VIEWS OF CONSUMERS,

ADVOCATES AND PROVIDERS REGARDING BARRIERS TO COMMUNITY LIVING FOR PEOPLE WITH DISABILITIES. THE HIGH RANKING OFFICIALS HERE TODAY ILLUSTRATE THE

COLLABORATIVE AND COORDINATED EFFORT NEEDED TO ADDRESS THE IMPORTANT TASK AT HAND.

THEY WILL BE WORKING WITH YOU AND THEIR STATE AND LOCAL COUNTERPARTS TO ACHIEVE FULL COMPLIANCE WITH TITLE II OF THE AMERICANS WITH DISABILITIES ACT.

THIS JOINT EFFORT ALSO WILL FACILITATE OPPORTUNITIES FOR PEOPLE WITH DISABILITIES TO LIVE, WORK, AND RECEIVE SERVICES IN THEIR OWN OWN COMMUNITIES.

YOUR INPUT WILL BE PART OF A REPORT THAT I HAVE ASKED MEMBERS OF MY ADMINISTRATION TO SUBMIT TO ME BY OCTOBER 16TH EXAMINING BOTH THE BARRIERS TO COMMUNITY LIVING AS WELL AS SOLUTIONS TO THOSE BARRIERS.

THIS REPORT WILL REPRESENT JUST ONE OF MANY STEPS THAT I AM COMMITTED TO TAKING TO CARRY OUT MY NEW FREEDOM INITIATIVE. I LOOK FORWARD TO RECEIVING THE RECOMMENDATIONS IN THIS REPORT AND TO IMPLEMENTING QUICK ACTION THAT MORE FULLY OPENS THE DOOR TO COMMUNITY LIVING FOR PEOPLE WITH DISABILITIES. BEST WISHES FOR INFORMATIVE AND PRODUCTIVE SESSIONS, GEORGE W. BUSH."

TODAY MARKS THE FIRST TIME THAT FEDERAL AGENCIES HAVE GATHERED TOGETHER TO HEAR THE VIEWS OF CONSUMERS, ADVOCATES AND PROVIDERS FROM ACROSS THE NATION ABOUT BARRIERS TO COMMUNITY LIVING FOR

PERSONS WITH DISABILITIES AND HOW TO REMEDY THESE BARRIERS.

AS YOU KNOW, WE ARE HERE TODAY AS A RESULT OF EXECUTIVE ORDER NUMBER 13217 ON COMMUNITY-BASED ALTERNATIVES FOR INDIVIDUALS WITH DISABILITIES THAT PRESIDENT BUSH SIGNED ON JUNE 18TH.

THE ORDER UNDERSCORES THE ADMINISTRATION'S COMMITMENT TO FULL IMPLEMENTATION OF THE AMERICAN WITH DISABILITIES ACT AND TO BREAK DOWN BARRIERS TO COMMUNITY LIVING. THE EXECUTIVE ORDER IS PART OF THE NEW FREEDOM INITIATIVE, WHICH THE PRESIDENT ANNOUNCED AS ONE OF HIS FIRST ACTS. THE NEW FREEDOM INITIATIVE PLEDGES THE ADMINISTRATION'S SUPPORT TO MAKE THE ADA A REALITY AND TO BREAK DOWN THE REMAINING BARRIERS THAT PERSONS WITH DISABILITIES FACE IN TODAY'S SOCIETY.

COMMUNITY INTEGRATION, THAT IS ALLOWING PERSONS WITH DISABILITIES TO BE FULL, CONTRIBUTING MEMBERS OF SOCIETY IN THEIR OWN COMMUNITIES, IS AN IMPORTANT PART OF THE NEW FREEDOM INITIATIVE AND THE EXECUTIVE ORDER. THE PRESIDENT HAS ASKED US TO DO A NUMBER OF IMPORTANT TASKS IN CONJUNCTION WITH OUR SISTER FEDERAL AGENCIES TO PROMOTE COMMUNITY INTEGRATION.

ONE OF THESE TASKS IS TO SUBMIT THE REPORT, AS THE PRESIDENT REFERENCED IN HIS LETTER, TO HIM BY OCTOBER 16 THAT LAYS OUT AND IDENTIFIES THE BARRIERS AND SOLUTIONS TO ACHIEVE COMMUNITY INTEGRATION.

IT IS VITALLY IMPORTANT TO THE PRESIDENT, AND IT IS IMPORTANT TO THE TEN FEDERAL AGENCIES THAT ARE PARTICIPATING IN TODAY'S LISTENING SESSION, TO HEAR FROM YOU ABOUT THE REAL LIFE $$5\end{tabular}$

CHALLENGES YOU FACE AND THE SOLUTIONS YOU PROPOSE. THAT IS WHY THE PRESIDENT SPECIFICALLY REQUESTED THAT WE GET THE INPUT OF CONSUMERS, ADVOCATES, AND PROVIDERS TO DEVELOP THE REPORT.

TODAY'S NATIONAL LISTENING SESSION IS THE CULMINATION OF A COMPREHENSIVE AND MULTIFACETED PUBLIC INPUT PROCESS THAT HAS INCLUDED A NUMBER OF DIFFERENT FORUMS, FROM A TOLL FREE CONFERENCE CALL TO A SOLICITATION OF WRITTEN AND E-MAIL COMMENTS.

ANOTHER IMPORTANT ASPECT OF THE EXECUTIVE ORDER IS THAT IT FOCUSES ON INTERAGENCY COLLABORATION.

THE PRESIDENT HAS ASKED FEDERAL AGENCIES TO WORK TOGETHER, WITH HHS AS THE LEAD, AND HAS ASKED FEDERAL AGENCIES TO WORK WITH STATES TO FACILITATE COMMUNITY INTEGRATION AND SWIFT IMPLEMENTATION OF THE SUPREME COURT'S OLMSTEAD DECISION.

TOWARD THIS END, WE HAVE FORMED AN INTERAGENCY COORDINATING COUNCIL ON COMMUNITY LIVING THAT INCLUDES, NOT ONLY THE SIX FEDERAL AGENCIES THAT THE PRESIDENT INITIALLY NAMED IN HIS EXECUTIVE ORDER, BUT ALSO FOUR ADDITIONAL FEDERAL AGENCIES THAT HAVE VOLUNTARILY JOINED THIS EFFORT.

WE WILL HAVE REPRESENTATIVES FROM THESE AGENCIES HERE WITH US TODAY THROUGHOUT THE DAY.

AND I WOULD LIKE TO INTRODUCE THE REPRESENTATIVES WHO ARE HERE TODAY ON THE DIAS STARTING THIS LISTENING SESSION THIS MORNING.

LET ME GO DOWN THE LIST HERE, DOWN THE DIAS.

I HAVE JOANNE WILSON, WHO IS THE NEWLY APPOINTED -- FROM THE DEPARTMENT OF EDUCATION -- COMMISSIONER FOR REHABILITATION SERVICES.

AS I UNDERSTAND, JOANNE WAS JUST CONFIRMED LAST MONTH, AND SHE'S NEWLY ON BOARD.

WELCOME WITH US, JOANNE.

AND I WANT TO GIVE YOU AN OPPORTUNITY, IF YOU HAVE A FEW WORDS TO SAY VERY BRIEFLY AS WELL, TO ADDRESS THE AUDIENCE. >> SECRETARY ROB PAGE, SECRETARY OF EDUCATION, REGRETS THAT HE COULDN'T BE HERE THIS MORNING.

BUT I KNOW THAT HE WOULD WANT ME TO SAY THAT HE HAS A FIRM COMMITMENT, WHICH HE HAS TOLD ME LOTS OF TIMES, THAT NO PERSON WITH A DISABILITY WILL BE LEFT BEHIND.

MYSELF, I'M, AS YOU WERE JUST TOLD, THE COMMISSIONER OF THE REHABILITATION SERVICES ADMINISTRATION.

BUT MY BACKGROUND IS FOR YEARS I HAVE BEEN A CONSUMER AND AN ADVOCATE, AS A PERSON WITH A DISABILITY AND AS A PERSON THAT FOR YEARS, BEFORE I GOT TO BE IN THIS POSITION WITH AN ADVOCATE LIKE YOU FOR PERSONS WITH DISABILITIES, I'M HERE TO REALLY LISTEN AND TO HEAR WHAT YOU HAVE TO SAY AND TO TAKE SOME ACTION AND DO WHAT NEEDS TO BE DONE. BOB PASTERNAK, THE ASSISTANT SECRETARY FOR THE OFFICE OF SPECIAL EDUCATION REHABILITATION SERVICES WILL BE SWITCHING OFF WITH ME TODAY DURING THE DAY.

HE'LL BE HERE THIS MORNING, AND I WILL BE BACK AGAIN THIS AFTERNOON.

AND BOTH OF US WANT TO CARRY THE MESSAGE THAT WE'RE HERE TO LISTEN TO YOU AND TO TAKE SOME ACTION IN OUR NEW POSITIONS. THANK YOU.

>> I SEE THAT MY COLLEAGUE FROM HUD IS HERE THIS MORNING, ALPHONSO JACKSON IS THE DEPUTY SECRETARY OVER AT HUD, A MAN WHO IS ALWAYS BUSY RUNNING AROUND TOWN, AROUND THE COUNTRY, PROVIDING OPPORTUNITIES IN HOUSING.

I WANT TO GIVE HIM AN OPPORTUNITY TO GET SETTLED IN. ALPHONSO, DID YOU HAVE A COMMENT THAT YOU WANTED TO SHARE WITH US THIS MORNING?

>> GOOD MORNING.

I HOPE YOU ALL REALLY, THIS MORNING, APPRECIATE MY GREENNESS. AND I WANT TO SHOW YOU THIS SHIRT BECAUSE MY WIFE BOUGHT IT FOR ME.

SO MOST MEN KNOW WHEN YOUR WIFE BUYS YOU SOMETHING, YOU HAVE TO WEAR IT.

SO AFTER A WHILE, YOU KNOW, YOU TRY TO AVOID IT, BUT EVENTUALLY SHE ASKS YOU, WHEN ARE YOU GOING TO WEAR THE SHIRT?

AND SHE SAYS, OH, YOU HAVE GOT THIS GREEN SUIT, THAT SHIRT WOULD GO GREAT. SO HERE I AM. [LAUGHTER].

LET ME SAY ON BEHALF OF SECRETARY MARTINEZ AND THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT, I WOULD LIKE TO THANK SECRETARY

THOMPSON AND DEPUTY SECRETARY ALLEN FOR THEIR LEADERSHIP IN DEVELOPING INTERAGENCY COUNCIL ON COMMUNITY LIVING AND FOR

CONVENING THIS CONFERENCE.

HUD IS COMMITTED TO OPENING THE DOORS OF AFFORDABLE HOUSING OPPORTUNITIES FOR INDIVIDUALS WITH DISABILITIES.

HUD SECTION EIGHT HOUSING VOUCHER PROGRAM IS ONE OF THE BEST FOR ACHIEVING THIS GOAL.

SINCE 1997, WE HAVE DISPENSED WITH SOME 50,000 VOUCHERS AS OF FISCAL YEAR 2000.

WE ARE NOW IN THE PROCESS OF DISPENSING 14,000 MORE VOUCHERS.

WE BELIEVE THAT IT IS IMPORTANT TO HAVE ACCESSIBILITY TO HOUSING IN THIS COUNTRY FOR EVERY AMERICAN.

I CAN TELL YOU THAT HUD IS COMMITTED TO A SWIFT

IMPLEMENTATION OF THE EXECUTIVE ORDER 13217 AND WILL DILIGENTLY WORK WITH THE

FEDERAL AGENCIES, OTHER FEDERAL AGENCIES, TO MAKE SURE THAT

IT IS CARRIED OUT.

IT IS SECRETARY MARTINEZ' BELIEF THAT EVERY AMERICAN IS

JUST AS IMPORTANT AS EVERY OTHER AMERICAN AND THAT WE WILL WORK WITH

HEALTH AND HUMAN SERVICES, WITH SECRETARY ALLEN, SECRETARY

THOMPSON, AND THE OTHER AGENCY

HEADS TO MAKE SURE THAT YOUR NEEDS ARE ADDRESSED.

THANK YOU SO MUCH.

>> GOOD MORNING, EVERYONE.

>> GOOD MORNING.

>> ON BEHALF OF THE DEPARTMENT OF JUSTICE, JOHN ASHCROFT, RALPH BOYD, THE ASSISTANT ATTORNEY GENERAL FOR CIVIL RIGHTS, WHO WILL JOIN US SOME TIME LATER TODAY, I WANT TO WELCOME YOU TO THIS SESSION.

I PARTICIPATED IN THE TELECONFERENCE THAT WAS HELD A FEW WEEKS AGO AND WAS VERY HEARTENED BY THE FACT THAT WE HEARD VERY CONSTRUCTIVE COMMENTS AND CONCERNS ABOUT OUR EFFORTS TO INTEGRATE DISABLED PERSONS INTO SOCIETY AND TO REMOVE BARRIERS

THAT HAVE EXISTED FOR FAR TOO LONG.

SO TODAY I WOULD ALSO WELCOME YOUR INPUT IN OUR PROCESS.

THIS IS A VERY IMPORTANT PROCESS TO ELIMINATE THESE BARRIERS TO COMMUNITY LIVING FOR PERSONS WITH DISABILITIES.

WE CANNOT SOLVE PROBLEMS AND REMOVE BARRIERS WITHOUT HEARING FROM YOU: PEOPLE WITH DISABILITIES, PEOPLE WHO ADVOCATE ON

BEHALF OF OTHERS WITH DISABILITIES, AND THOSE OF YOU WHO WORK WITHIN STATE GOVERNMENT AND THE HEALTH CARE SYSTEM.

WE ARE HERE TODAY TO LISTEN.

I ALSO HAVE MY COLLEAGUE JOHN WODATCH HERE AND OTHER PEOPLE

ROM THE DEPARTMENT OF JUSTICE.

PLEASE FEEL FREE TO APPROACH US DURING THE INTERMISSIONS

AND ANY OTHER TIME.

PLEASE FEEL FREE TO CALL US WITH YOUR IDEAS.

TOGETHER, WE CAN PLAY AN IMPORTANT ROLE IN REUNITING AMERICA'S FAMILIES AND COMMUNITIES WHILE PROVIDING PERSONS WITH DISABILITIES OPPORTUNITIES TO LIVE INDEPENDENTLY AND WITH DIGNITY.I LOOK FORWARD TO HEARING FROM YOU. THANK YOU VERY MUCH.

>> AND REPRESENTING THE DEPARTMENT OF LABOR, SECRETARY CHAO, IS HER DEPUTY SECRETARY, D. CAMERON FINDLAY. >> GREAT PLEASURE FOR ME TO BE HERE ON BEHALF OF THE DEPARTMENT OF LABOR AND MY BOSS, SECRETARY ELAINE CHAO, WHO REGRETS SHE CAN'T BE HERE TODAY.

SHE TOO IS WITH HER COUNTERPARTS FROM MEXICO.

AS SOME OF YOU MAY KNOW, SECRETARY CHAO CHAIRS THE PRESIDENTIAL TASK FORCE ON THE EMPLOYMENT OF ADULTS WITH DISABILITIES.

IT'S A VERY IMPORTANT ASSIGNMENT FOR THE DEPARTMENT OF LABOR BECAUSE A BIG PART OF OUR PORTFOLIO IS PROVIDING TRAINING AND EMPLOYMENT SERVICES TO ALL AMERICANS, INCLUDING THOSE WITH DISABILITIES. AND LET ME SAY THAT WE ARE ABSOLUTELY COMMITTED TO HELPING DISABLED PEOPLE GET THE SKILLS THEY NEED TO SUCCEED IN THE 21ST CENTURY WORK FORCE.

JUST LAST WEEK, WE FINISHED CONDUCTING AN AGENCY-BY AGENCY REVIEW AT THE DEPARTMENT TO DETERMINE HOW ALL OF OUR PROGRAMS CAN BETTER SERVE THE DISABLED COMMUNITY. FOR EXAMPLE, WE WANT TO MAKE SURE THAT OUR ONE-STOP

EMPLOYMENT

CENTERS, WHICH ARE THROUGHOUT THE COUNTRY, AGGRESSIVELY REACH OUT TO THE DISABLED COMMUNITY.

ANOTHER EXAMPLE, WE ARE VERY INTERESTED IN HELPING DISABLED

VETERANS THROUGH OUR MANY VETERANS TRAINING PROGRAMS,

INCLUDING SOMETHING CALLED DVOP, AND THE CLASSIC WASHINGTON ACRONYM.

THAT'S THE DISABLED VETERANS OUTREACH PROGRAM.

THE DEPARTMENT'S ONE-STOP EMPLOYMENT CENTERS IN PARTICULAR

ARE VERY GOOD RESOURCES FOR IDENTIFYING JOBS AND UPGRADING SKILLS.

AND WE BELIEVE THEY ARE A VERY IMPORTANT COMPONENT OF THE

PRESIDENT'S NEW FREEDOM INITIATIVE THAT CAN HELP THE DISABLED REACH THEIR FULL POTENTIAL.

LET ME BE VERY CLEAR.

WE BELIEVE THAT INTEGRATING THE DISABLED INTO THE WORK

FORCE IS NOT MERELY THE RIGHT THING TO DO, IT IS AN ABSOLUTELY CRITICAL

THING TO DO FOR THE 21ST CENTURY WORK FORCE.

ONE OF THE THINGS THAT WE FACE AT OUR DEPARTMENT IS A GROWING SKILLS GAP.

AND WE SIMPLY CAN'T AFFORD TO IGNORE A LARGE PERCENT OF OUR POPULATION THAT CAN FILL THAT SKILLS GAP MERELY BECAUSE OF OUTMODED THINKING OR UNNECESSARY IMPEDIMENTS. SO TOGETHER WITH MY COLLEAGUES, GARY REED AND BILL MCKINNON, WHO WILL BE HERE FOR THE ENTIRE DAY, I LOOK FORWARD TO HEARING FROM ALL OF YOU. AND I WANT TO THANK YOU IN ADVANCE FOR PARTICIPATING IN THIS VERY IMPORTANT FORUM. THANKS. >> THANKS, CAM.

AND WE ALSO HAVE OUR ACTING COMMISSIONER FOR THE SOCIAL SECURITY ADMINISTRATION, LARRY MASSANARI..

LARRY?

>> GOOD MORNING.

IT IS GOOD TO BE WITH YOU THIS MORNING. THOSE OF US FROM SOCIAL SECURITY ARE VERY PLEASED TO BE A PART OF THIS INTERAGENCY EFFORT THAT IS FOCUSED ON IMPROVING THE AVAILABILITY OF COMMUNITY-BASED SERVICES. AND WE ARE NOW CONDUCTING A THOROUGH REVIEW OF OUR PROGRAMS WITH THIS GOAL IN MIND.

I WOULD LIKE TO THANK SECRETARY THOMPSON AND DEPUTY SECRETARY ALLEN FOR CONVENING THE SESSION TODAY. THEY ARE VERY GRATEFUL AT SOCIAL SECURITY FOR THEIR VERY STRONG AND FOCUSED -- AND I WOULD QUICKLY ADD, THEIR VERY CREATIVE LEADERSHIP OF THIS GOVERNMENT-WIDE EFFORT. I THINK MOST OF YOU HERE THIS MORNING KNOW HOW IMPORTANT T THE SOCIAL SECURITY AND SSI PROGRAMS CAN BE TO PROMOTING

COMMUNITY LIVING.

THEY ARE THIS NATION'S TWO LARGEST CASH BENEFIT PROGRAMS FOR PEOPLE WITH DISABILITIES.

AND SOCIAL SECURITY AND SSI ALSO PROVIDE THE GATEWAY TO MEDICARE AND MEDICAID.

AND THESE CASH BENEFIT AND MEDICAL BENEFIT PROGRAMS ARE OFTEN ESSENTIAL TO INDIVIDUALS AND INDIVIDUAL'S ABILITY TO LIVE IN THE LEAST RESTRICTIVE SETTING.

WE ALSO KNOW HOW IMPORTANT EMPLOYMENT CAN BE IN HELPING FOSTER INDEPENDENCE.

AND ONE OF OUR HIGHEST PRIORITIES AT SSA IS ENCOURAGING AND HELPING PEOPLE WITH DISABILITIES FIND OR RETURN TO WORK.
