Participate in meeting with supervisor to discuss regulation development, including, strategy, guidance, updates, goals deliverables; Office duties. Completing internal paperwork such as issuing Open Burning Permits, completing travel authorizations, reports. Attend meetings such as Navajo Nation Council and Resources Committee; Visits to source locations, filter change-out at air monitoring locations, in general, filling in where personnel are needed. Attend Trainings/Conferences; Occasionally, school presentation are given and public meeting are held to gather communication concerns and to increase awareness of our program's activities.
