


Figure 1.1. Percent of persons of all ages without health insurance coverage: United States, 1997-2004

- In early 2004, the percent of uninsured persons was 14.6% (95% CI = 13.8%-15.5%), which was lower than, but not significantly different from, the 2003 estimate of 15.2%.
- The annual percent of uninsured persons was 15.4% in 1997, 14.6% in 1998, 14.2% in 1999, and 14.9% in 2000. The estimate increased from 14.3% in 2001 to 15.2% in 2003.

The number of uninsured was calculated as the percent of uninsured multiplied by the total weighted population including persons with unknown coverage. The age-specific numbers of uninsured may not add to their respective totals due to rounding error. Age-adjusted estimates for persons under 65 years old for this Healthy People 2010 Leading Health Indicator are adjusted to the 2000 projected U.S. standard population using three age groups: under 18 years, 18-44 years, and 45-64 years.

- In early 2004, the percent of uninsured persons was 16.4% (41.5 million) for persons under age 65 years, 19.5% (35.1 million) for persons aged 18-64 years, and 8.8% (6.4 million) for children under age 18 years.
- For adults aged 18-64 years, there was an increasing trend in the percent of those
- who were uninsured from 2001 to 2003. The estimate in early 2004 was lower than, but not significantly different from, the estimate in 2003.
- For children under age 18 years, the percent of those who were uninsured decreased from 13.9% in 1997 to 8.8% in early 2004.



The resulting estimates of persons having public or private coverage are within 0.1-0.3 percentage points of those based on the editing procedures used for the final data files.

- In early 2004, 16.1% of persons under age 65 years were covered by public plans, and 68.7% were covered by private health insurance plans.
- For persons aged 18-64 years, from 1999 to early 2004, there was an increasing trend in public coverage and a decreasing trend in private coverage. The estimate for private coverage in early 2004 was higher than, but not significantly different from, the estimate in 2003.
- For children under age 18 years, from 1999 to early 2004, there was an increasing trend in public coverage and a decreasing trend in private coverage. The estimate for private coverage in early 2004 was higher than, but not significantly different from, the estimate in 2003.



Figure 1.2. Percent of persons under age 65 years without health insurance coverage, by age group and sex: United States, January-March 2004



The resulting estimates of persons not having health insurance coverage are generally 0.1-0.2 percentage points lower than those based on the editing procedures used for the final data files.

- For both sexes combined, the percent of those who were uninsured was highest among persons aged 18-24 years (31.5%) and lowest among persons under age 18 years (8.8%) and at ages 45-64 years (12.8%). Starting at age 18 years, younger adults were more likely than older adults to lack health insurance coverage.
- Among adults in the age groups 18-24 years, 25-34 years, and 35-44 years, men were more likely than women to lack health insurance coverage.

The resulting estimates of persons not having health insurance coverage are generally 0.1-0.2 percentage points lower than those based on the editing procedures used for the final data files. Estimates are age-sex-adjusted to the 2000 projected U.S. standard population using three age groups: under 18 years, 18-64 years, and 65 years and over.

- After adjusting for age and sex, the percent of uninsured persons was 33.1% for Hispanic persons, 10.2% for non-Hispanic white persons, and 16.8% for non-Hispanic black persons.
- Hispanic persons were most likely to be uninsured, followed by non-Hispanic black persons and non-Hispanic white persons.



Figure 2.1. Percent of persons of all ages with a usual place to go for medical care: United States, 1997-2004





- In early 2004, the percent of persons who had a usual place to go for medical care was 86.4% (95% CI = 85.5%-87.4%), which was lower than the 2003 estimate of 87.9%.
- The annual percent of persons of all ages who had a usual place to go for medical care was 86.2% in 1997, 87.4% in 1998, 86.3% in 1999, 87.0% in 2000, 88.0% in 2001, 87.6% in 2002, and 87.9% in 2003.



Figure 2.2. Percent of persons of all ages with a usual place to go for medical care, by age group and sex: United States, January-March 2004



- Of the five age groups, persons aged 18-24 years were least likely to have a usual place to go for medical care. Children under age 18 years were more likely than adults aged 18-64 years to have a usual place to go for medical care.
- For adults aged 18-64 years, men were less likely than women to have a usual place to go for medical care.
- Among those aged 18 years and over, the percent of persons having a usual place to go for medical care increased with age group.

- After adjusting for age and sex, the percent of persons with a usual place to go for medical care was 75.2% for Hispanic persons, 88.9% for non-Hispanic white persons, and 86.1% for non-Hispanic black persons.
- Of the three race/ethnicity groups, Hispanic persons were least likely to have a usual place to go for medical care.



Figure 3.1. Percent of persons of all ages who failed to obtain needed medical care due to cost at some time during the past 12 months: United States, 1997-2004



- In early 2004, 5.6% (95% CI = 5.1%-6.1%) of the population was unable to obtain needed medical care due to cost at some time during the past 12 months. The estimate is slightly higher than, but not significantly different from the 2003 estimate of 5.3%.
- From 1998 through early 2004, an increasing trend has been observed in the percent of persons who experienced this lack of access to medical care (4.2% in 1998 to 5.6% in early 2004).



- For both sexes combined, the percent of persons who were unable to obtain needed medical care due to cost at some time during the past 12 months was 2.4% for those aged under 18 years, 7.4% for those aged 18-64 years, and 2.5% for those aged 65 years and over.
- For adults 18-64 years, women were more likely than men to have experienced this lack of access to medical care during the past 12 months.

- After adjusting for age and sex, 7.0% of Hispanic persons, 5.2% of non-Hispanic white persons, and 6.4% of non-Hispanic black persons were unable to obtain needed medical care due to cost at some time during the year preceding the interview.
- Hispanic persons were more likely than non-Hispanic white persons to experience this lack of access to medical care.



Beginning in September 2003, respondents were asked about influenza vaccination by nasal spray (sometimes called by the brand name FluMist™) in addition to the question regarding the flu shot. Estimates of nasal spray flu vaccination are not presented in this Early Release.

- In the first quarter of 2004, the percent of adults who had received an influenza shot during the past year was 70.3% for persons aged 65 years and over, 40.6% for persons aged 50-64 years, and 19.3% for persons aged 18-49 years.
- For persons aged 65 years and over, the first quarter estimate increased from 63.3% in 2001 to 66.6% in 2002 to 67.8% in 2003 to 70.3% in 2004 (delays in availability of the flu shots occurred in the fall of 2000, and to a lesser extent, in the fall of 2001) (6,7).



The estimate in 2003 was similar to the estimates in 2002 and 1999 (delays in the availability of influenza shots occurred in the fall of 2000, and to a lesser extent, in the fall of 2001) (6,7).



Figure 4.2. Percent of adults aged 18 years and over who had received an influenza shot during the past 12 months, by age group and sex: United States, January-March 2004





Figure 5.1. Percent of adults aged 65 years and over who had ever received a pneumococcal vaccination: United States, 1997-2004



Figure 5.2. Percent of adults aged 65 years and over who had ever received a pneumococcal vaccination, by age group and sex: United States, January-March 2004





Figure 6.1. Prevalence of obesity among adults aged 20 years and over: United States, 1997-2004



- In early 2004, 25.1% (95% CI = 23.8%-26.3%) of U.S. adults aged 20 years and over were obese, which is similar to the 2003 estimate of 23.7%.
- The prevalence of obesity among U.S. adults aged 20 years and over has increased over time from 19.4% in 1997 to 25.1% in early 2004. The estimate in 2003 was lower than, but not significantly different from that in 2002.



Figure 6.2. Prevalence of obesity among adults aged 20 years and over, by age group and sex: United States, January-March 2004





Figure 7.1. Percent of adults aged 18 years and over who engaged in regular leisure-time physical activity: United States, 1997-2004



- In early 2004, 29.7% (95% CI = 28.3%-31.1%) of U.S. adults aged 18 years and over engaged in regular leisure-time physical activity. This estimate was lower than, but not significantly different from, the 2003 quarter one estimate of 31.3%.
- The annual percents of adults aged 18 years and over who engaged in regular leisure-time physical activity increased from 29.9% in 1998 to 31.9% in 2000, remained stable from 2000 to 2002, and increased from 2002 to 2003. The increase from 2002 to 2003 was not statistically significant.



Figure 7.2. Percent of adults aged 18 years and over who engaged in regular leisure-time physical activity, by age group and sex: United States, January-March 2004





Figure 8.1. Prevalence of current smoking among adults aged 18 years and over: United States, 1997-2004





Figure 8.2. Percent distribution of smoking status among adults aged 18 years and over, by sex: United States, January-March 2004



Figure 8.3. Prevalence of current smoking among adults aged 18 years and over, by age group and sex: United States, January-March 2004





Figure 9.1. Percent of adults aged 18 years and over who had 5 or more drinks in 1 day at least once in the past year: United States, 1997-2004









Figure 10.1. Percent of adults aged 18 years and over who had ever been tested for HIV: United States, 1997-2004





Figure 10.2. Percent of adults aged 18 years and over who had ever been tested for HIV, by age group and sex: United States, January-March 2004







Figure 11.2. Percent distribution of respondent-assessed health status, by sex for all ages: United States, January-March 2004



Figure 11.3. Percent of persons of all ages who assessed their health as excellent or very good, by age group and sex: United States, January-March 2004





Figure 12.1. Percent of adults aged 65 years and over who need help with personal care from other persons: United States, 1997-2004





Figure 12.2. Percent of adults aged 65 years and over who need help with personal care from other persons, by age group and sex: United States, January-March 2004





Figure 13.1. Percent of adults aged 18 years and over who experienced serious psychological distress during the past 30 days: United States, 1997–2004





Figure 13.2. Percent of adults aged 18 years and over who experienced serious psychological distress during the past 30 days, by age group and sex: United States, January-March 2004





Figure 14.1. Prevalence of diagnosed diabetes among adults aged 18 years and over: United States, 1997-2004





Figure 14.2. Prevalence of diagnosed diabetes among adults aged 18 years and over, by age group and sex: United States, January-March 2004





Figure 15.1. Percent of persons of all ages who experienced an asthma episode in the past 12 months: United States, 1997-2004





Figure 15.2. Percent of persons of all ages who experienced an asthma episode in the past 12 months, by age group and sex: United States, January-March 2004





Figure 15.4. Prevalence of current asthma among persons of all ages: United States, 2001-2004





Figure 15.5. Prevalence of current asthma among persons of all ages, by age group and sex: United States, January-March 2004


