## **Major Duties:**

The Crop Conversion Science and Engineering Unit located at the Eastern Regional Research Center, Agricultural Research Service in Wyndmoor, Pennsylvania is seeking to fill a permanent position for a Biological Science Technician. Incumbent actively participates in one or more phases of the research process by performing a variety of complex duties, in a laboratory, field, or greenhouse environment. Performs experiments which are designed to provide answers for specific research problems areas. Searches literature for methods to meet assignment objectives. Carries out measurements and analyzes by applying established chemical methods using personal computers. Analyzes the results according to established principles and procedures. Keeps detailed records of experimental data. Tabulates, statistically and summarizes data using personal computers and software packages. Maintains inventory of chemicals, general laboratory cleanliness and, supplies and materials appropriate to research work.

**Qualifications Required:** Your education and experience will be evaluated against all qualification requirements (basic and any additional requirements) listed below.

### **Basic Requirements**

Applicants must have either education or specialized experiences as follows: For GS-05: Applicant must have 1 full year of specialized experience equivalent to the GS-04 level; OR, successfully completed a full year course study leading to a bachelor's degree, with major study in a field of biology, chemistry, statistics, entomology, animal husbandary, botany, physics, agriculture, or mathematics. For the GS-06: Applicants must have 1 year of specialized experience equivalent to at least GS-5, OR one half academic year of related graduate level education. For GS-07: Applicants must have 1 year of specialized experience equivalent to the GS-06 level, OR 1 full year of related graduate level education. A combination of education and experience may be qualifying.

**If qualifying all or in part based on your education, please submit a copy of your college transcripts OR a list of college courses with credit hours, dates completed, and grades received. If this information is not provided, your education may not be appropriately evaluated and you may lose consideration for this position. If your qualifications are based in any part on education and you are selected for this position, you will have to provide an official copy of your academic transcripts prior to entering on duty.**

**Specialized Experience** - experience which has equipped you with the following Knowledge, Skills and Abilities - 'KSAs' required to perform the duties of this position:

1. Knowledge of principles of biological science.
2. Skill to operate and maintain complex equipment systems which must be calibrated and synchronized to achieve desired results.
3. Skill in keeping exact and detailed records of data obtained from experiments.
4. Skill in the use of personal computers and software packages in the data collection, analysis and presentation processes.

Well-qualified means the applicant meets the basic qualification and eligibility requirements and all selective placement factors; is rated above minimally qualified against the KSAs or quality criteria; and is able to satisfactorily perform the duties of the position upon entry. Applicants must submit the following:

- 1) a copy of your RIF Separation Notice or Certification of Expected Separation or other documentation indicating that you are a surplus employee;
- 2) evidence of full performance level of current position;
- 3) a copy of your most recent performance appraisal; and
- 4) a copy of your most recent SF-50, Notification of Personnel Action, to verify reassignment eligibility.

### **Selective Service System:**

Males over age 18 who were born after December 31, 1959, must have registered with the Selective Service System (or have an exemption) to be eligible for Federal employment.
