#### SCHEDULE OF PROPOSED ACTIONS November 1, 2002

The attached is the Schedule of Proposed Actions (SOPA) for the Rio Grande National Forest and San Luis Resource Area. The schedule includes project proposals that we currently anticipate working on during the winter of 2002/2003.

This schedule is not a NEPA document, nor is it a solicitation for comments. Comments addressed to the schedule do not provide standing for appeal purposes. The purpose of the Schedule of Proposed Actions is to provide you with information on whom to contact should you wish to become involved through site-specific comments. This only provides enough information to enable you to contact the proper person to become involved in the analysis and decision process on the forest. Comments received by project leaders, including names and addresses of those who comment, will be considered part of the public record on the proposed action and will be available for public inspection. Comments submitted anonymously will be accepted and considered; however, those who submit anonymous comments will not have standing to appeal the subsequent decision under 36 CFR Parts 215 or 217. Additionally, pursuant to 7 CFR 1.27(d), any person may request the agency to withhold a submission from the public record by showing how the Freedom of Information Act (FOIA) permits such confidentiality. Persons requesting such confidentiality should be aware that, under the FOIA, confidentiality may be granted in only very limited circumstances, such as to protect trade secrets. The Forest Service will inform, the requestor of the agency's decision regarding the request for confidentiality, and where the request is denied, the agency will return the submission and notify the requester that the comments may be resubmitted with or without name and address within (xx) days.

We welcome your interest and participation. We also encourage your involvement in each project that you are interested in. Your participation is particularly helpful during the early stages of project formulation known as "scoping". It is during the "scoping" process that we define the Purpose and Need for the project, identify issues and define the extent of analysis that is needed. All projects are scoped separately from this SOPA. If you identify a project or projects that you are interested in, please contact the ID Team Leader shown on the schedule and provide project specific comments.

On January 19, 2001, the Chief's Office issued a decision on Appeal #97-13-00-0057 of the Record of Decision for the Rio Grande National Forest Revised Land and Resource Management Plan. Subsequently, the Secretary issued a discretionary review decision of the Chief's appeal decision on March 29, 2001. All Forest decisions on proposed actions must be consistent with the Secretary's review decision. Issuance of a Forest decision will be guided by the Secretary's instructions and public comment.

# **BLM SCHEDULE OF PROPOSED ACTIONS**



## San Luis Resource Area

This proposal is being submitted by BLM to Colorado's Governor's Energy Office as a clean water project. Clean water and healthy watersheds form the basis of resilient ecosystems, benefiting not only public land values but also adjacent communities. BLM gives its highest priority to protecting riparian and aquatic habitat and restoring shrub and grassland habitats that are integral to overall watershed health.

There are four phases to this project. In Phase I, BLM proposes to relocate six-tenths of a mile of Ford Creek Road (#5270) from Ford Creek flood prone area and creek side to an adjacent terrace. In Phase II, another six-tenths mile of road will be improved to reduce excessive sediment and water runoff into Ford Creek. After the new road construction is complete, Phase III stream enhancement projects will be executed to put the stream back into its original channel and stabilize banks at locations where the old road forced the streams out of its channel and into the opposite hill side. Finally, outside the scope of this proposal, Phase IV will include monitoring for noxious and invasive weeds. Additionally, annual maintenance will be applied until equilibrium has been reached and the stream is once again in balance with the sediment and water being supplied, and there is no further threat of a noxious weed invasion.
