Background:

The Centers for Disease Control and Prevention (CDC) established a national system of Centers for Public Health Preparedness to focus on improving the capacity of the front line public health and health care worker to respond to bioterrorism, other infectious disease outbreaks, and other public health threats and emergencies. Established in FY 2000, the Centers for Public Health Preparedness (CPHP) program serves as an integrated national system that provides a continuum of accessible learning opportunities for frontline workers throughout their careers. This program is aimed at providing professional workforce development services to personnel at State and local health departments, communitybased organizations and other entities charged to carry out CDC programs in general and bioterrorism and infectious disease control and prevention, in particular.

The CPHP program funds three types of centers-academic, specialty and local health department exemplars. *Academic* or comprehensive base centers link schools of public health with state, local and regional needs; *Specialty* centers address unique content (public health law), discipline-specific (nursing) or technology (advance distance learning) needs; while *Local Exemplars* or *Advanced Practice* sites focus on operational readiness, communications and/or information technology and training applications.

Funded Centers conduct activities which: 1) support state and local public health agencies in achieving preparedness capacities for bioterrorism and emergency response; 2) facilitate implementation of the National Public Health Training Plan for Bioterrorism Preparedness; and 3) support the vision outlined in the CDC Strategic Plan for Public Health Workforce Development.
