SECOND OF SEVEN GUILTY DEFENDANTS SENTENCED FOR CONSPIRING TO MANUFACTURE METH

KANSAS CITY, Mo. – Todd P. Graves, United States Attorney for the Western District of Missouri, announced a Kansas City woman was sentenced in federal court today for her role in a conspiracy to manufacture methamphetamine in Kansas City, Mo.

Wanda J. Wing, 31, of Kansas City, Mo., was sentenced by U.S. District Judge Fernando J. Gaitan, Jr., this morning to five years in federal prison without parole.

On Feb. 19, 2003, **Wing** pleaded guilty to conspiring to manufacture 50 grams or more of methamphetamine. By pleading guilty, Graves said, **Wing** admitted to conspiring to manufacture methamphetamine between April 10, 2001, and Oct. 7, 2002. She also admitted to purchasing Sudafed pills and supplying pseudoephedrine for the purpose of manufacturing methamphetamine.

Wing is the second guilty co-defendant to be sentenced in this case.

Robert C. Barnett, 37, of Kansas City, Mo., was sentenced by U.S. District Judge Fernando J. Gaitan, Jr., to nine years in federal prison without parole.

On Jan. 7, 2003, **Barnett** pleaded guilty to his role in a conspiracy to manufacture 50 grams or more of methamphetamine between April 10, 2001, and Oct. 7, 2002.

Five other co-defendants also have pleaded guilty to their roles in the conspiracy to manufacture 50 grams or more of methamphetamine during the same time period.

On April 25, 2003, **Clinton M. Robinson**, 21, and **Bryan Barnett**, 33, both of Kansas City, pleaded guilty to manufacturing 50 grams or more of methamphetamine. **Richard A. Stewart**, 45, and **William R. Barnett**, 38, both of Kansas City, pleaded guilty to the same charge

on April 17, 2003. **Tina Dravenstott**, 23, of Kansas City, pleaded guilty on April 15, 2003.

As a result of pleading guilty, the defendants each face a maximum sentence of up to life in federal prison without parole, plus a \$4 million fine. Their sentences will be determined according to the United States Sentencing Guidelines. Sentencing hearings will be scheduled after the completion of a presentence report by the U.S. Probation Office.

The case is being prosecuted by Assistant U.S. Attorney Catherine A. Connelly. It was investigated by the Kansas City Metro Meth Task Force.
