- THERE IS NO FEE TO HAVE A U.S. PASSPORT AMENDED. Your amended U.S. passport and any documentary evidence submitted will be returned to you by first-class mail.
- For faster processing, you request Expedited Service. Expedite requests will be processed in three workdays from receipt at a Passport Agency. The fee for expedited service is \$35. Enclose the \$35 expedite fee in the form of a personal check or money order. All fees should be payable to the "U.S. DEPARTMENT OF STATE." Do not send cash. Expedited Service is available only in the United States.
- If you desire SPECIAL POSTAL SERVICE (overnight mail, special delivery, etc.), include appropriate postage fees.
 NOTE: A passport agency will NOT mail a passport to a private address outside the United States.
