U.S. Department of Labor Funds Grants to Help Ex-Offenders. DOL's Secretary Elaine Chao announced a \$10 million grant to Public/Private Ventures to help ex-offenders ages 18 to 34 make a successful transition to community life and long-term employment. These grants will benefit former offenders in 14 cities nationwide. Four of the grants are juvenile sites. U.S. Department of Labor (DOL) Announces Grant to the National Urban League. DOL Secretary Elaine Chao has announced a \$9.2 million grant to the National Urban League to assist inner-city African American youth. Through their grant, the National Urban League will bring the Youth Career Preparation Program to 15 urban sites across the country. Youth ages 16-24 will be involved in internships and on-the-job training to help them prepare for full-time jobs in the private sector. U.S. Department of Labor (DOL) Funds Grant for Hispanic Youth. DOL announced a \$2.76 million grant to help at-risk Hispanic youth in five locations across the country. The grant will provide education and training services to youth already involved with the criminal justice system or at-risk of involvement. Funds will be used to serve 600 youth, 120 in each of five locations, Orlando, Miami, Chicago, New York and Philadelphia. The Employment and Training Administration (ETA) at the U.S. Department of Labor releases its "New Strategic Vision for the Delivery of Youth Services under the Workforce Investment Act (WIA)." ETA released its vision to serve out-of-school and at-risk youth under WIA. Under the new vision WIA funded youth programs will provide leadership to connect these youth with quality secondary and postsecondary educational opportunities, and employment opportunities. The vision is part of the Training and Employment Guidance Letter (TEGL 3-04), designed for State Workforce Agencies and State Workforce Liaisons.
