SUBJECT: MID-CYCLE PERFORMANCE REVIEW AND INSPECTION PLAN -

PEACH BOTTOM ATOMIC POWER STATION (50-277, 50-278)

Dear Mr. Skolds:

On August 7, 2002, the NRC staff completed its mid-cycle plant performance assessment of Peach Bottom Atomic Power Station Units 2 and 3. In accordance with NRC Inspection Manual Chapter 0305 "Operating Reactor Assessment Program," the mid-cycle review involved the participation of all technical divisions in evaluating the performance of your Peach Bottom facility for the first half of the current assessment cycle, January 1 - December 31, 2002. The purpose of this letter is to inform you of our assessment of your safety performance during this period and our plans for future inspections at your facility so that you will have an opportunity to prepare for these inspections and to inform us of any planned inspections which may conflict with your plant activities.

Plant performance for the most recent quarter was within the Regulatory Response Column of the NRC's Action Matrix based on one inspection finding of low to moderate safety significance (White) in the Emergency Preparedness cornerstone. The inspection finding in the Emergency Preparedness cornerstone involved inadequate maintenance of the on-site public address/evacuation alarm system. The significance of this finding was finalized in our letter dated August 22, 2001. On October 26, 2001, we satisfactorily completed a supplemental inspection of this finding using supplemental inspection procedure 95001. The supplemental inspection determined that Exelon's actions relative to root cause determination, extent of condition, and corrective action were appropriate.

In a letter dated July 19, 2002, we identified two new preliminary White findings in the Emergency Preparedness cornerstone. The preliminary findings involve an inadequate critique of an emergency preparedness exercise and an untimely classification of an Alert during an actual event that occurred on June 2, 2002. The final significance of these findings is still under our review as part of the Significance Determination Process.

The enclosed inspection plan details the inspections scheduled through September 30, 2003. The inspection plan is provided to minimize the resource impact on your staff and to allow for scheduling conflicts and personnel availability to be resolved in advance of inspector arrival onsite. Routine resident inspections are not listed due to their ongoing and continuous nature. The last six months of the inspection plan is tentative and may be revised at the end-of-cycle review

In addition, the NRC is in the process of finalizing a Temporary Instruction (TI) that will be used to review implementation of the Interim Compensatory Measures required by the Agency's Security Order to all commercial nuclear power plants dated February 25, 2002. Schedules have not yet been finalized, but it is anticipated that these inspections will begin within the next calendar quarter. Once finalized, the details will be communicated by separate correspondence.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be made available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
