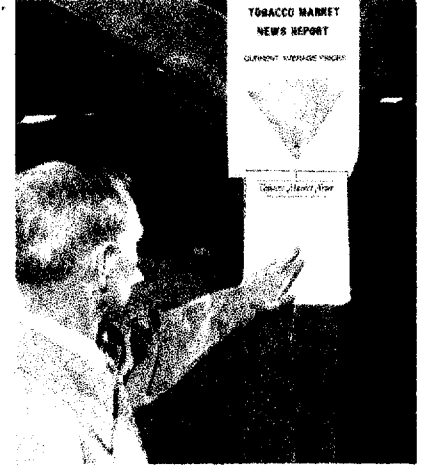

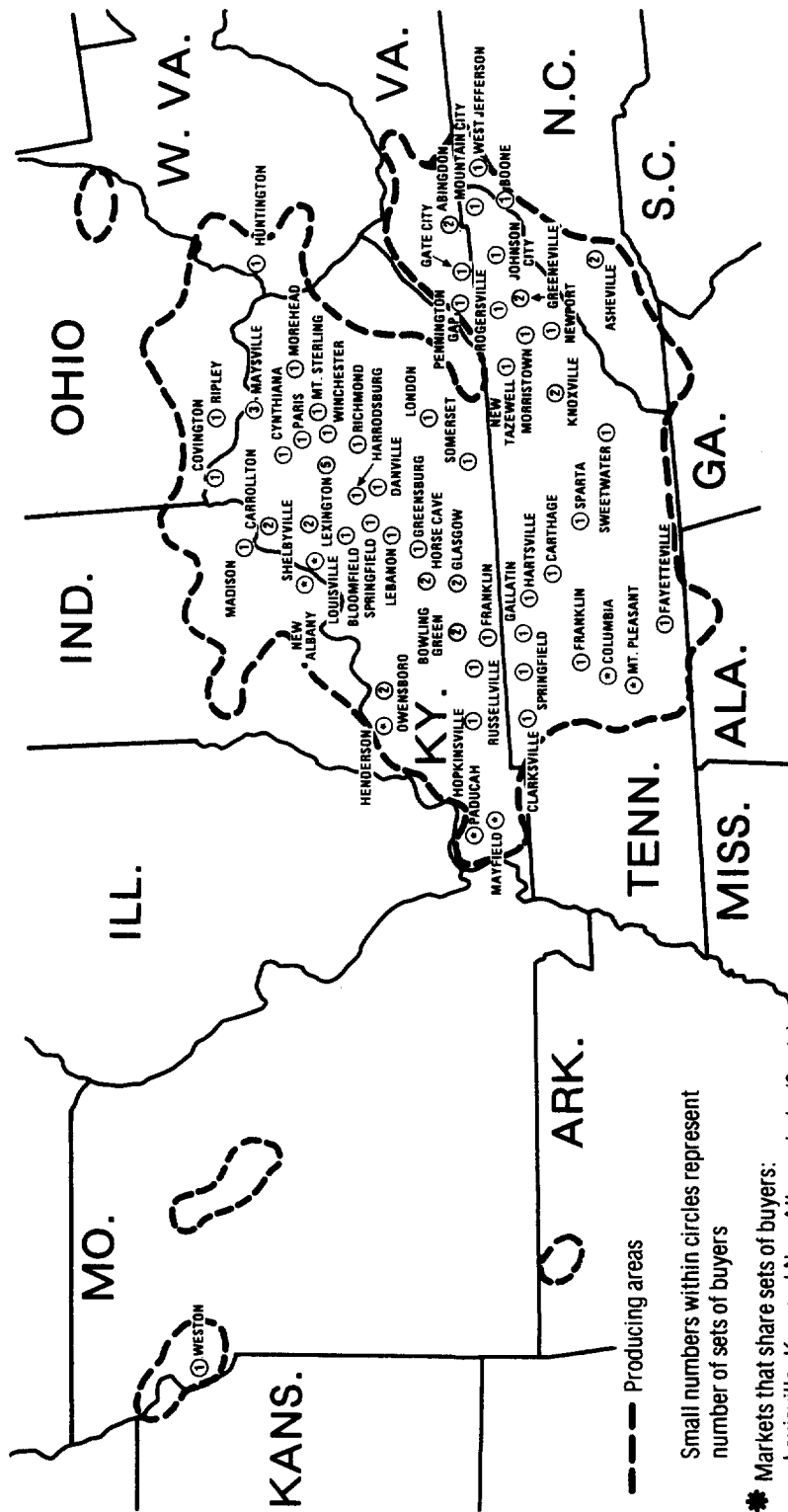

The statistics on sales and markets in this review were compiled from reports and records of auction sales from the State Departments of Agriculture of Kentucky, Tennessee, North Carolina, Virginia and West Virginia; from data furnished by marketing recorders employed through the offices of the Agricultural Stabilization and Conservation Service (ASCS); and from information received directly from markets and trade sources. The statistics on prices by grades were based on the compilation of auction data recorded from warehouse sales tickets from representative markets in the burley area.

Review of the 1982/83 Marketing Season

Burley tobacco growers produced the largest crop ever in 1982. Although the general average was lower than the record set the previous year, money received was up somewhat. The percentage of sales placed under loan showed a tremendous increase this year. Price support was available for tobacco tied or baled. Burley displayed in sheets carried support from opening day in Virginia due to a court imposed restraining order requested by growers. Similar orders were also imposed in some Tennessee and Kentucky markets during the following weeks. The USDA lifted restrictions on December 3, 1982 and provided price support for sheeted tobacco during the rest of the 1982-83 season on all Burley markets. The amount sold in sheets was estimated at 6 percent of sales. Auctions began this season November 17 and a final clean-up was held March 24, making a total of 45 sales days--5 more than last year. A program to handle excess tobacco was implemented through the Burley Cooperatives with approximately 33 million pounds placed in the program. Farmers are to receive the 1983 price support for this tobacco in October with the poundage deducted from their 1983 quota.

Gross sales totaled 850.6 million pounds averaging \$180.59 per hundred--down 12 cents from last season. Producers' sales totaled 774 million pounds bringing \$1,401 million for an average of \$180.96.

About 70 percent of the grade averages were generally \$5 to \$10 per hundred lower than last season. The few grades recording gains were better quality marketings and increases corresponded closely with the rise in the support price. The practical top price was \$195 per hundred pounds.

This year's marketings consisted of a smaller percentage of mixed-stripped tobacco. From a color standpoint, more red, tannish red and mixed appeared for sale with less tan, variegated, green and greenish. Due to warm and damp weather in November, the amount of wet tobacco increased, particularly before Christmas.

The Burley Cooperatives received 268.6 million pounds of tobacco (31.6 percent of gross sales), this is the largest poundage of any year for this area. Better quality lugs, cutters and leaf accounted for a majority of receipts.

Type 32, Maryland

There was no federal inspection or market news again on the four auction markets in Maryland during the past marketing season. In a mail referendum held in February 1982, eighty-four percent of the producers who voted opposed mandatory USDA inspection of their product.

Growers in Maryland had been receiving free mandatory grading and market news services from USDA since 1948.

Under the Omnibus Budget Reconciliation Act of 1981, however, user fees were imposed for auction sales at designated auction markets. Since Maryland, Type 32 tobacco has not been under production quotas or price support since 1965, growers petitioned the Secretary of Agriculture to conduct the referendum allowing them to vote on terminating the designation of the four auction markets: Hughesville, LaPlata, Upper Marlboro, and Waldorf.
