BUYS: Canned Fruit

The Department of Agriculture (USDA) purchased canned fruit under an Indefinite Delivery-Indefinite Quantity Contract for distribution to needy families, child nutrition and other domestic food assistance programs, according to Robert Keeney, Deputy Administrator, Fruit and Vegetable Programs, Agricultural Marketing Service.
