The U.S. Department of Agriculture (USDA) invites offers to sell fresh potatoes as indicated below and per the Announcement for distribution to child nutrition and other domestic food assistance programs. Offers are due by **1:00 p.m., Central time, Tuesday, August 10, 2004.** Acceptances will be announced by midnight, August 24, 2004. Deliveries are to be made from December 13, 2004 through April 30, 2005.

Offers are invited from the trade for:

Potatoes Russet, Fresh	50 lb carton	14,400 cartons
Potatoes White Round, Fresh	50 lb bag	4,800 bags

No offer will be made to 8(a) vendors on this invitation.

All invitations with orders for the state of New York must have the pack date stamped on the outside of each carton. The pack date should be annotated as per the following example: (05/01/2003). Orders for the state of New York requiring the special markings will be indicated by (**). This applies to New York orders "Only", if and when they appear on an invitation.

Note: Funds are not presently available for contracts awarded for FY2005. The Government's obligation for contracts issued is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise until funds are made available to the Contracting Officer for these contracts and until the Contractor receives notice of such availability in writing from the Contracting Officer.

Bids must be submitted electronically via the Domestic Electronic Bid Entry System (DEBES) on the internet. <u>Offerors who submit bids using other than DEBES</u>, will be deemed <u>non-responsive</u>.
