➤ Preliminary data indicate that there were 32 murders known to police in Nevada from January through March 2003. During full year 2002, there were 184 murders known to police in Nevada. 26

- ➤ In March 2003, the Nevada Highway Patrol made 44 drug arrests. ²⁷ In February 2003, the Highway Patrol made 32 drug arrests. ²⁸ The Highway Patrol made 49 drug arrests during January 2003. ²⁹ During full year 2002, 747 drug arrests were made by the Nevada Highway Patrol. ³⁰
- ➤ In March 2003, the Nevada Division of Investigations made 41 arrests for drug violations.³¹ There were 38 drug arrests made by the Division of Investigations during February 2003.³² The Division of Investigations made 36 drug arrests during January 2003.³³ During full year 2002, the Division of Investigations made 324 drug arrests.³⁴

Drugs

> Cocaine

Cocaine, particularly crack cocaine, is a significant problem in the urban areas of Nevada. Cocaine HCL is moderately available in northern Nevada and readily available throughout the southern areas of the state.³⁶

> Heroin

Mexican black tar heroin remains the most prevalent form of heroin available in Nevada.³⁷

> Marijuana

Domestically cultivated and Mexican grown marijuana remain readily available in Nevada. In June 2001, Assembly Bill 453 was signed into law allowing patients to use marijuana for medicinal purposes.³⁸

➤ Methamphetamine

Methamphetamine, both imported into the state and locally produced, remains the principal drug of concern in Nevada. The purity level for methamphetamine imported into the state ranges from 9% to 26%. Locally-produced methamphetamine is often of a higher purity level, averaging 90%. ³⁹

Club Drugs

The availability of club drugs in Nevada ranges from sporadic in the northern urban areas of the state to readily available in cities in the southern section of the state, particularly Las Vegas. Club drugs are typically abused in local nightclubs, adult entertainment clubs, and at raves.⁴⁰

- > Other Drugs
 - The pharmaceutical drugs of choice in Nevada include Lortab, Hydrocodone, Xanax, Codeine, Diazepam, and Oxycodone. Prescription forgery and doctor shopping remain the primary methods by which pharmaceutical drugs are diverted in Nevada.⁴¹
- According to 2000-2001 data from the National Household Survey on Drug Abuse (NHSDA), approximately 40% of Nevada citizens ages 12 and older felt that smoking marijuana once a month posed a great risk.⁴²

Juveniles

Results of a 2001 survey of Nevada high school students indicate that 7.7% of the students used marijuana on school property at least once during the past month. Approximately 18% of students reported first trying marijuana before the age of 13.⁴⁴

Enforcement

- ➤ Drug Enforcement Administration Mobile Enforcement Teams⁴⁷
 Conceived in 1995 in response to the overwhelming problem of drug-related violent crime in towns and cities across the nation, the DEA's Mobile Enforcement Team (MET) program is a cooperative effort involving Federal, state and local law enforcement counterparts. There have been two MET deployments in Nevada since the inception of the program, taking place in Reno and Carson City.
- As of October 31, 2002, there were 8,312 full-time law enforcement employees in Nevada (4,907 officers and 3,405 civilians).⁴⁸

Trafficking and Seizures

- ➤ Due to its close proximity to California and its porous border, Nevada often serves as a transshipment point for various drugs to the central and eastern sections of the United States. 49
- ➤ During full year 2003, the DEA and state and local authorities in Nevada reported 121 methamphetamine lab incidents to the El Paso Intelligence Center.⁵⁰

Courts

- ➤ Drug Courts⁵⁴
 - As of November 2003, there were 12 drug courts in Nevada that have been in existence for more than 2 years, 7 that were recently implemented, and 8 that were being planned.
- ➤ During FY 2001, 21.9% of Federally-sentenced defendants in Nevada were charged with drug offenses. Methamphetamine was involved in 55 (48.2%) of the drug offenses. ⁵⁵

Corrections

- ➤ At the end of 2002 (December 31), there were 10,478 prisoners under the jurisdiction of state or Federal correctional authorities in Nevada, a 2.4% increase in the prison population since December 31, 2001.⁵⁶
- The number of adults on probation in Nevada decreased 1% in 2002, from 12,416 on January 1 to 12,290 on December 31.⁵⁷
- ➤ The adult parole population in Nevada decreased 1.3% in 2002, from 4,025 on January 1 to 3,971 on December 31.⁵⁸

Consequences of Use

From October 1, 2002 to September 30, 2003, there were 22 methamphetamine laboratory sites in Nevada in which a child was present.⁵⁹
