Crime and Drug-Related Crime

➤ In January 2004, there were 2,272 adult arrests for Part I offenses in Pennsylvania. During full year 2003, there were more than 55,000 adult arrests for Part I offenses in the state.³¹

- ➤ The Pennsylvania State Police Bureau of Drug Law Enforcement (BDLE) made 640 arrests during 2002.³³
- ➤ During 2001, the Drug Enforcement Administration (DEA) reported making 805 arrests for drug violations in Pennsylvania.³⁴

Drugs

Cocaine

Powder and crack cocaine are widely available and frequently abused in Pennsylvania. In the 2nd quarter of FY 2003, powder cocaine sold for \$20,000-35,000/kilogram, \$800-1,600/ounce, and \$28-125/gram, while crack sold for \$3-50/rock. Pennsylvania cocaine purity levels were 60-95% for powder cocaine and 80% for crack.³⁵

> Heroin

Heroin (primarily South American) has surpassed cocaine as the greatest drug threat in most of Pennsylvania.³⁶ Heroin availability is increasing in western Pennsylvania, where purity is also increasing and prices are decreasing.³⁷ In the 2nd quarter of FY 2003, heroin sold for \$80,000-\$110,000/kilogram, \$2,000-6,500/ounce and \$10-40/bag in Pennsylvania. The heroin analyzed during that quarter ranged in purity from 40 to 95%.³⁸

Marijuana

Marijuana remains abundantly available in wholesale and retail quantities in Pennsylvania.³⁹ Most of the marijuana available in Pennsylvania is produced in Mexico. However, significant quantities of locally-produced marijuana and marijuana produced in other states, Canada, and Jamaica are also available.⁴⁰ In the 2nd quarter of FY 2003, marijuana sold for \$3,000-4,000/kilogram, \$500-2,000/pound, \$80-225/ounce, and \$5-35/bag in Pennsylvania.⁴¹

➤ Methamphetamine

The production and abuse of methamphetamine are increasing threats to Pennsylvania, particularly in the northwestern parts of the state. In the 2nd quarter of FY 2003, meth sold for \$8,000-13,000/pound, \$700-2,000/ounce, and \$80-200/gram. Meth purity during that quarter ranged from 25% to 60%.

Club Drugs

MDMA is most readily available in the state's larger cities and on or near college campuses. MDMA sells for \$9-35/tablet at the retail level. GHB sells for \$10-20/dosage unit. 43

> Other Drugs

Pharmaceutical drugs such as Dilaudid, OxyContin, Vicodin, and Xanax pose a serious drug threat to Pennsylvania. OxyContin sells for \$1/milligram; Dilaudid sells for \$20/20 milligram tablet; Vicodin sells for \$4-7/tablet; and Xanax sells for \$1-5/tablet.

According to 2000-2001 data from the National Household Survey on Drug Abuse (NHSDA), approximately 45% of Pennsylvania citizens ages 12 and older felt that smoking marijuana once a month posed a great risk.⁴⁵

➤ In January 2004, there were 742 juvenile arrests for Part I offenses in Pennsylvania. During full year 2003, there were 19,206 such arrests in the state. 47

- Results of a 2001 survey of Pennsylvania students indicate that 21.2% of high school seniors statewide reported being high or drunk at school on at least one occasion within the past year.
- ➤ Students from southwest Pennsylvania reported the highest prevalence levels statewide for lifetime and past 30 day marijuana use (24.3% and 13.3%, respectively). Students from north central Pennsylvania reported the lowest lifetime and past 30 day prevalence rates (15.6% and 8.4%, respectively). ⁵⁰
- ➤ Approximately 47% of Pennsylvania high school seniors surveyed in 2001 reported using marijuana at least once during their lifetimes.⁵¹

Enforcement

- ➤ The Operations Division of the Pennsylvania BDLE is organized into 5 geographic regions comprised of 15 Tactical Narcotics Teams located throughout the Commonwealth, as well as an Eastern and Western Interdiction Team. ⁵³
- ➤ Clandestine Laboratory Response Team (CLRT)⁵⁴
 The Pennsylvania State Police CLRT is made up of 51 certified members (as of 2002): 32 BDLE members, 10 Bureau of Forensic Services Forensic Scientists, and 19 Special Emergency Response Team members.
- As of October 2002, there were 28,183 full-time law enforcement employees in Pennsylvania (23,713 officers and 4,470 civilians).⁵⁵

Trafficking and Seizures

- Most of the illicit drugs available in Pennsylvania are transported into the state from New York City. 56
- ➤ Central Pennsylvania is known as a crossroads for shipments of wholesale quantities of drugs moving west from New York City and Philadelphia as well as shipments moving northeast from Florida and the Southwest Border.⁵⁷
- During full year 2003, the DEA and state and local authorities in Pennsylvania reported 51 methamphetamine lab incidents to the El Paso Intelligence Center.⁵⁸

- ➤ The Pennsylvania State Police seized 32 methamphetamine labs during 2002.⁵⁹
- ➤ A total of 168.9 kilograms of cocaine were seized by the BDLE during 2002.⁶⁰

- ➤ In 2002, there were 7,308 marijuana plants eradicated in Pennsylvania under the DEA's Domestic Cannabis Eradication/Suppression Program. ⁶³

Courts

➤ Drug Courts⁶⁶

As of November 2003, there were 15 drug courts in existence or being planned in Pennsylvania. Six of the drug courts have been in existence for more than 2 years, 5 were recently implemented, and 4 were being planned.

➤ During FY 2001, approximately 37% (36.9%) of the Federally-sentenced defendants in Pennsylvania had committed drug offenses. Thirty-four percent of the drug offenses (200 offenses) involved crack cocaine. ⁶⁷

Corrections

- As of January 31, 2004, the total Pennsylvania Department of Correction (DOC) inmate population was 40,836. This is greater than the DOC facility capacity, which is 34,439.⁶⁸
- From January 2003 to January 2004, the DOC inmate population increased 1.1%.⁶⁹
- On January 31, 2004, approximately 1,703 Pennsylvania inmates were in Therapeutic Community (TC) programs and 161 were in Residential Substance Abuse Treatment (RSAT) programs.⁷⁰
- ➤ On December 31, 2002, there were 6,084 Pennsylvania inmates who committed drug offenses, representing 15.1% of the total inmate population. This is up from December 31, 2001, when there were 5,480 drug offenders representing 14.4% of the inmate population.⁷¹
- ➤ The average time served in Pennsylvania for drug offenses decreased 19.3% from 37.3 months in 2001 to 30.1 months in 2002.⁷²
- ➤ Drug Interdiction Unit⁷³
 Since the implementation of the Drug Interdiction Unit in 1995, the K-9 teams have played a role in approximately 400 drug finds while searching cells, common areas within state prisons, and vehicles.
- ➤ At the end of 2002, there were 130,786 adults on probation and 97,712 adults on parole in Pennsylvania.⁷⁴
- > Treatment alternatives for Pennsylvania parole violators include the following:⁷⁵
 - Substance Abuse Violators Effort (SAVE): One of the two SAVE programs is geared toward sentenced offenders with substance abuse problems who would normally be returned to a state correctional facility due to technical parole violations. The second SAVE program is for sentenced offenders with substance abuse problems who have been returned to a county correctional facility due to technical parole violations. If an offender is referred to either SAVE program and fails the program, he or she is automatically referred to the RSAT program.
 - Residential Substance Abuse Treatment (RSAT): Like SAVE, the RSAT program
 provides an alternative to long-term recommitment for technical parole violators
 with substance abuse problems. RSAT is comprised of three phases involving a
 therapeutic community, placement in a community corrections center, and
 intensive supervision.

Consequences of Use

➤ From October 1, 2002 to September 30, 2003, there were 2 Pennsylvania methamphetamine laboratory sites reported to the El Paso Intelligence Center in which a child was present. ⁷⁶
