



## **Medicaid HIPAA Outreach Activities**

Since July of 2000, the Center for Medicaid and State Operations (CMSO) within CMS has undertaken an effort to assist state Medicaid programs in preparing to implement changes to their systems and business processes. The following list contains some of those activities and Web sites.

- CMS created a browser-based HIPAA information model to help states and other interested entities and individuals. This model is called the Medicaid HIPAA Compliant Concept Model (MHCCM) and can be used to conduct a HIPAA gap analysis, showing HIPAA impacts and where action will be needed to become compliant.
