Planning Update #7

The Record of Decision adopting the Little Pend Oreille Refuge Comprehensive Conservation Plan has been signed

The Record of Decision (ROD) adopting the preferred alternative described in the Little Pend Oreille National Wildlife Refuge Final Environmental Impact Statement and associated Comprehensive Conservation Plan (Final CCP/EIS) was signed on May 31, 2000. Dan Diggs, acting Regional Director for the U.S. Fish and Wildlife Service (Service) signed the ROD upon the completion of a 30-day comment period following the release of the Final CCP/EIS.

Signing the ROD means that implementation of the adopted alternative may begin. The adopted alternative outlines actions to benefit wildlife and eliminate or modify uses that conflict with the primary wildlife conservation mission at the Refuge.

Preferred Alternative E (modified from the Draft EIS released last May), emphasizes management and restoration of habitat along with a mix of existing uses and priority recreation activities. Five alternatives, including a no-action alternative, were considered in the planning process.

What Kinds of Changes Will Happen This Summer and Fall?

The Refuge plans to meet with interested horseback riders this summer to work on an equestrian plan. If interested, please contact Lisa Langelier, Refuge Manager.

The Refuge may also begin work on some pilot forest restoration projects, described in Appendix E of the Final CCP/EIS.

Dispersed riparian camping (camping within 300 feet of a stream, or within a

100-year floodplain) will be gradually phased out over the summer. The purpose of this action is to prevent further vegetation loss and erosion in riparian areas, and to begin rehabilitation of some sites. Notifications of closures will be posted at Refuge entrances. All five campgrounds will remain open under the CCP. If you have any questions or wish to assist in the effort to close and rehabilitate dispersed riparian camps, please contact the Refuge at the number above.
