Stone Lakes National Wildlife Refuge (refuge) invites you to participate in the public scoping process to develop a Comprehensive Conservation Plan (CCP) for the refuge. This multi-year, master planning process will produce a plan that will help guide refuge management for the next 15 years.

Participate in the Public Scoping Meetings

To begin developing the CCP, Stone Lakes NWR will hold four public scoping meetings in the evening to help identify issues and gather information.

For your convenience, we've selected four different locations and dates, hoping that one will work for you.

All meetings will begin at 7:00 p.m. and end at 9:00 p.m.

MONDAY, SEPTEMBER 16, 2002

Elk Grove Community Services District Board Room 8820 Elk Grove Blvd. Elk Grove, CA 95624

Directions: From Sacramento, take 99 South, exit Elk Grove Blvd, turn left (east). Drive approximately 1 mile to the brick building on right, just before Elk Grove-Florin Road.

THURSDAY, SEPTEMBER 26, 2002

Clunie Community Center (Auditorium)-McKinnley Park 601 Alhambra Blvd. Building for meeting is on F Street. Sacramento, CA 95816

Directions: From Elk Grove, take 99 North toward Sacramento. Continue on Business 80 east toward Reno. Take the H Street exit and merge left on to 30th Street. Turn right on G Street, then turn left onto Alhambra Blvd. The building is on the right.

WEDNESDAY, OCTOBER 2, 2002

Jean Harvie Community Center 14273 River Road Walnut Grove, CA 95690

Directions: From Sacramento, take I-5 South, exit Twin Cities Road-Highway 104. Go right and continue to the Tintersection.. Turn left on River Road, follow through Locke and into Walnut Grove. At the three-way stop sign, go straight through the intersection. Jean Harvie Community Center is on the left side of the road, just after the second bridge, approximately 1/2 mile from the intersection.

THURSDAY, OCTOBER 10, 2002

Veterans Memorial Center -(Club Room) 203 East 14th Street (corner of 14th & B Street) Davis, CA 95616

Directions: From Sacramento, take I-80 West to Davis. Take the Richards Blvd. exit, and bear right onto Richards Blvd. Pass under the railroad tracks, then turn left on 1st Street. Then turn right on B Street. Continue to end and turn left on West 14th Street. Building is on the corner of 14th & B streets. The Club Room is off the courtyard.

What is a CCP?

The National Wildlife Refuge System Improvement Act of 1997, provides the U.S. Fish and Wildlife Service with guidance for managing refuges to ensure the long-term conservation of fish, wildlife, plants, and their habitats. The Act identifies the need for long term master plans, and requires each refuge to develop a Comprehensive Conservation Plan (CCP). Three important principles of the Act that guide CCP development are to maintain biological integrity and diversity, maintain the environmental health of the refuge, and facilitate compatible wildlife-dependent recreation.

The act requires every refuge to have

a CCP completed by 2012. The CCP will outline refuge goals, objectives, and management strategies. It is meant to be a flexible, "living" document that will be updated at least every 15 years.
