#### **Report Highlights:**

South Africa's total production of apples, pears, and tablegrapes in CY2002 is expected to change marginally from last year, because of the fairly stable area planted. Farmers only replaced old orchards with new more competitive varieties. Deregulation and competitive exchange rate appear to be helping South Africa's fruit exports.

# **Executive Summary**

Total South African production of apples, pears, and tablegrapes in CY2002 is expected to change little from last year. Farmers are not increasing the area planted but are replacing old orchards with new more competitive varieties. Exports are expected to show an insignificant rise, although some improvement is possible based on the continued decline of the Rand. To boost exports, producers, exporters and government institutions have formed a joint venture (Marketing Forum) to better develop and coordinate export activities. Domestic consumption will also remain unchanged.

#### **Production**

South Africa's Cape Town Container Terminal (CTCT) is presently experiencing unprecedented growth in volumes, mainly because of lack of relatively accurate crop estimate as well as a slow and inaccurate flow of real intake information. In 2000, the Deciduous Fruit Producers' Trust (DFPT), through the Centre for International Agricultural Marketing and Development (CIAMD), developed a data base for crop estimates, crop intakes, crop distribution, and price benchmark. Information utilized is gathered from the primary producers, pack-houses and exporters.

South Africa's official produce quality inspection and certification service is delivered by the Perishable Products Export Control Board (PPECB). In the near future, PPECB's role will include handling certification for Good Agricultural Practices, especially EurepGAP(GAP), Hazard Analysis Critical Control Point (HACCP), Good Manufacturing Practices (GMP), Good Hygiene Practices (GHP), and other auditing functions to ensure food safety standards are met.

#### **Trade**

#### **Exports**

The peak export volumes for deciduous fruit handled by the port authorities, shipping lines, etc, during week 5-6 in MY 2001, was approximately 5.2 million cartons. Total deciduous fruit exports of approximately 75 million cartons is expected to grow to 92 million by 2005. Total fruit exports are expected to increase by more than 200,000 MT by 2005. CY2002 fresh produce exports is expected to reach R7,2 billion.

# **Policy**

The Deciduous Fruit Producers' Trust (DFPT) has released the 2002/03 guidelines on the use of plant protection chemicals, to ensure compliance with maximum chemical residue tolerances in countries to which South Africa export. The guidelines include export MRL's contained in the National Department of Agriculture (NDA), Directorate Plant Health and Quality (DPHQ) Export Grading Regulations, under Act 119, Agricultural Product Standards Act.
