## A. DESCRIPTION OF THE ACCIDENT SEQUENCE AND ACCIDENT PECULIARITIES

(Provide a summary of the accident sequence as well as any particular event of the accident that is noteworthy. Injury mechanism and vehicle crashworthiness is the focus, not driver culpability. Do not include any personal identifiers.)

Vehicle #1 was northbound on a 4 lane expressway exit ramp in the 3rd lane. Vehicle #1 departed the roadway to the right and sideswiped a concrete wall with the right side of vehicle #1 . Vehicle #1 then sideswiped a steel guard rail with the left side of vehicle #1. Vehicle #1 continued on and struck head-on, a concrete Hwy sign support base. Vehicle #1 was towed from the scene. All 4 occupants of vehicle #1 were transported to the hospital. The driver and front right seat passenger of vehicle #1 were fatally injured.

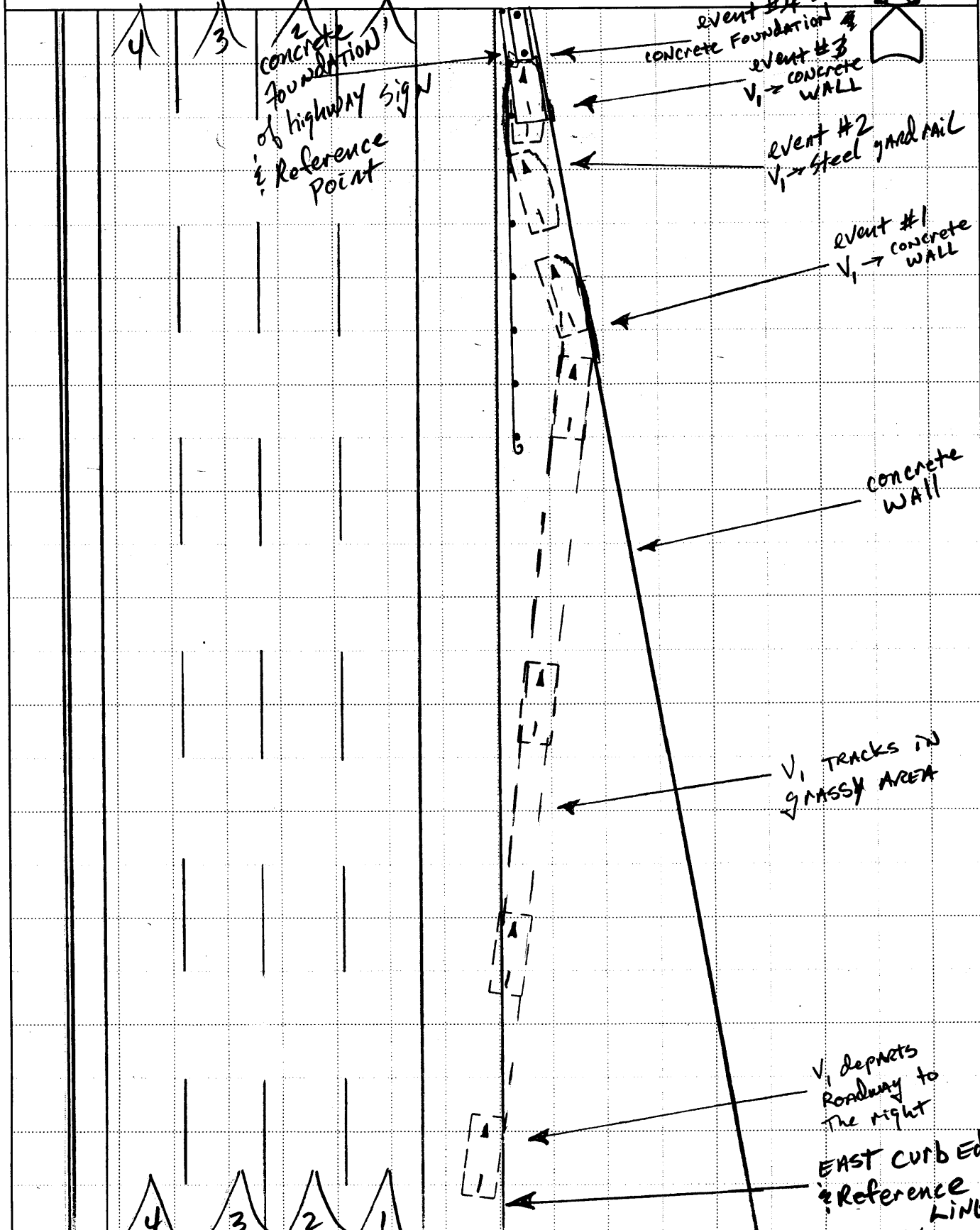

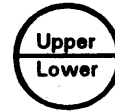

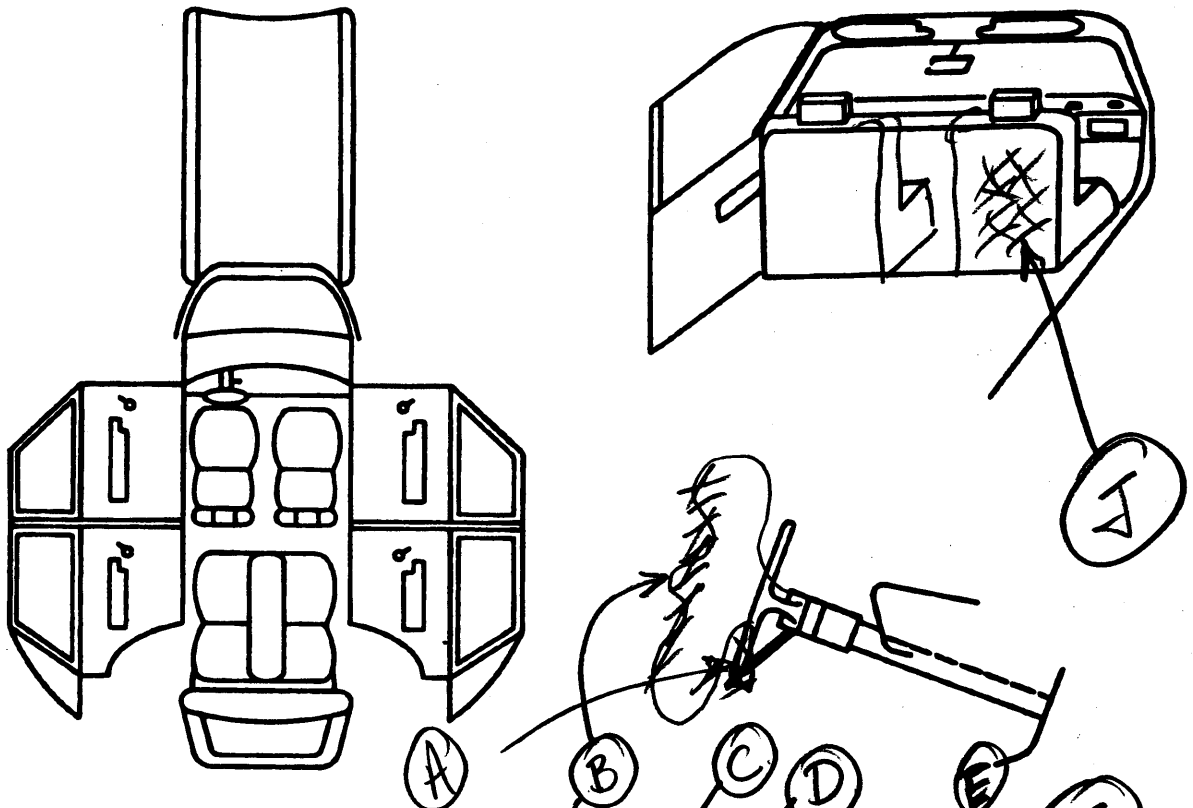
