- obtained a Certified Public Accountant or Certified Internal Auditor license through a written examination; OR
- obtained a degree with at least 15 semester hours in accounting/auditing if you have successfully worked at the full performance level in accounting, auditing or a related field, or at least two higher level professional

accountants or auditors have certified that your accounting experience equals the knowledge associated with a 4 year accounting/auditing degree.

Required Specialized Experience

Desired Experience

The most desirable candidates are CPAs with at least three years of public accounting experience with emphasis on public companies. At least one year of experience within the last three years should include knowledge of Federal securities laws, rules, and regulations, obtained by either the conduct of audits of public companies or the preparation or review of financial statements and other financial information of operating companies included in financial documents submitted to the SEC.
