





### ***Taking the Worst of the Worst Off the Streets***

Number of fugitive cases closed this calendar year by the Regional Fugitive Task Forces: **7,455**

<b>Capital Area Regional Fugitive Task Force</b>	
<p>In October of 2002, Ivan McKin was charged in James City County, Virginia with the drive-by shooting death of 16 year-old Gentry Kaine. McKin then fled Virginia. The FBI obtained an Unlawful Flight to Avoid Prosecution (UFAP) warrant on April 9, 2004. On May 24, 2004, James City County detectives and the FBI contacted the Capital Area Regional Fugitive Task Force (CARFTF), Norfolk Office, for assistance in locating and apprehending McKin. A lead was sent to investigators from the NY/NJ Regional Fugitive Task Force who located and arrested McKin without incident on June 2, 2004.</p>	 <p><b>Ivan Lim McKin</b> <b>Wanted for Homicide</b></p>

<b>Los Angeles Regional Fugitive Task Force</b>	
<p>Woon-Bae Chung was arrested by members of the Los Angeles Regional Task Force (LARFTF), Mexico City Liaisons, DHS, and Airport Police upon landing at Los Angeles Airport. Chung had been charged with kidnapping, aggravated assault and battery, false imprisonment, and battery on two police officers in Florida. Chung allegedly beat a pregnant woman so severely it caused the death of her unborn fetus. Responding police officers in Seminole County, Florida, also were attacked and beaten, resulting in Chung's escape. Chung fled to Germany then Mexico, where he was located by USMS Mexican Liaison Inspectors, who had Chung arrested and deported to Korea. Chung fought Mexican immigration authorities while being placed on the airplane. ### Great Lakes Regional Fugitive Task Force

On June 6, 2004, the Great Lakes Regional Fugitive Task Force (GLRFTF) arrested David Johnston in Eastern Missouri. Johnston was wanted for Manufacture of Methamphetamine in Lewis County, Missouri, and for questioning into the brutal murder of a 37 year-old woman who was severely burned and left to die an agonizing death. After extensive investigation, GLRFTF investigators received information that Johnston was possibly hiding out in a campground near Mark Twain Lake in Ralls County, Missouri. With the cooperation of USMS Eastern District of Missouri, Ralls County Sheriff, Lewis County Sheriff, and the lake water patrol, GLRFTF Investigators traveled to Ralls County and established the location of the person believed to be Johnston. GLRFTF investigators purported to be campers and engaged Johnston in conversation. Johnston was positively identified and taken into custody without incident.

### New York/New Jersey Regional Fugitive Task Force

On April 23, 2004, a warrant for the arrest of Kevon Holt was issued in the Southern District of New York, charging Holt with Hobbs Act robbery, criminal possession of a firearm during and in relation to a crime of violence, and other related offenses. The charges against Holt are a result of a long-term investigation involving a violent Jamaican drug and robbery organization. Holt also was the prime suspect in two separate homicides that occurred within the confines of New York Police Department's 32<sup>nd</sup> Precinct. On May 18, 2004, the US Attorney's Office in the Southern District of NY requested the assistance of the NY/NJ Regional Fugitive Task Force in the apprehension of Holt. On June 6, 2004, members of the Task Force, with the assistance of USMS Technical Operations Group, arrested Holt without incident in Brooklyn, NY.

### Southeast Regional Fugitive Task Force

On June 3, 2004, investigators from the Southeast Regional Fugitive Task Force (SERFTF) and the USMS Technical Operations Group located and arrested Maurice Robinson. Robinson was wanted by the Atlanta Police Department for Aggravated Assault with a Firearm. Robinson assaulted and robbed the son of a Major with the Atlanta Police Department. In an earlier confrontation with police, Robinson had managed to evade and elude them. Investigators feared that Robinson might attempt to kidnap his minor child and use the child as a shield in a confrontation with law enforcement. Robinson has a criminal history that includes two arrests for armed robbery, two arrests for eluding police, terrorist threats, several aggravated assaults with a firearm, and six firearms violations.
